Capertee & the surrounding district was very badly affected by the 2019/2020 bushfires, with life, property & livestock lost & threatened. This was exasperated by the drastic need for water. Capertee & District Progress Association Inc., on behalf of the community, are applying to purchase a Cat 6 Bulk Water Tanker (BWT) for the Capertee RFS. It will also be supporting other brigades of the district. The BWT has a far bigger capacity than other fire fighting vehicles, & will address the issue of having to leave the fire grounds to refill. It will benefit by supporting other brigades in our entire district, & its introduction will provide confidence that the RFS is better equipped for future events.

Detailed project description and key activities

Capertee & District was very badly affected by the Black Summer Bush fires, becoming totally encircled, with life, property & livestock lost. This situation was exasperated by the ongoing drastic need for a Category 6 Bulk Water Tanker (BWT). We are applying for a grant to provide Capertee RFS with one of these fully functional fire fighting vehicles as the water capacity is so much greater.

During the 2019/2020 bushfires, with the district having suffered months of drought, and with very little available water, the only way of supplying bulk water was by semi-trailer, which unfortunately couldn't traverse the fire trails & 4WD terrain to be able to get to the fireground. This resulted in crucial time wasted as RFS vehicles drove away from the fireground to fill up from the semi, before returning. Had a BWT been on site, at the fireground, it would been of great benefit.

The need of a BWT is long overdue, and could be utilized not only for bushfires, but all incidents that the local RFS brigade is called out to, such as house, grass & car fires.

An example of this need was an awful house fire in Capertee in which tragically a small child was killed. 8 tankers were used in the call out, of which 5 were used to supply water & were coming & going from the Capertee RFS station filling up, because none of them had the capacity of a Cat 6 BWT to remain on site.

Capertee & District Progress Association is applying for this grant to purchase this essential piece of fire-fighting equipment in order that it will help mitigate the damage of climate-related risks of bush fire. It will also support the mental health of the members of the community, including that of the fire fighters, providing confidence in the firefighting capabilities of the RFS of the district. The introduction of the Cat 6 BWT, will address the urgent and previously unmet needs of the local RFS brigade that fully became apparent during the 2019/2020 devastating bushfires.

We have the backing of the community, surrounding districts, and RFS units (including but not restricted to Glen Alice, Glen Davis, Bogee & Ilford), which will also benefit greatly from the BWT being available at Capertee, and we have the backing of Andrew Gee MP & Tony Abbott, who both experienced first-hand, the 2019/2020 bushfires in and around Capertee, the Capertee Valley & the surrounding district.

For whatever reason unknown to us, the RFS has not been able to equip

Capertee with a Cat 6 BWT in the past, so with this grant money, we will be to fill an urgent need for one. It will be ordered and engineered professionally by the RFS, and stationed at the Capertee RFS. We have been told that it will take approximately 2 years to be built to code, so we want to get the ball rolling prior to the threat of another devastating bushfire as its introduction will provide resilience for the future.

The 2019/2020 bushfires had a devastating effect on our economy and our community. The Capertee district is greatly dependent upon tourism, the Capertee Valley, which bore the brunt of the bushfires, is the widest canyon in the world, with an abundance of bird species & wildlife. The fires devastated vast areas of bushland, threatening the future of our natural heritage area. The recovery and resilience of the area is dependent upon more effective bushfire fighting methods and equipment, the Cat 6 BWT being integral in this. There were huge areas of bushfire ravaged areas, not only in the Valley, but all the way along the Castlereagh highway, being the areas that the Capertee RFS support. The fires had a negative affect on business & economic growth, not to mention extreme hardship for some property owners, and mental stress and anguish for those residents who were literally cut-off by the fires that cut the highway from Ben Bullen through to Running Stream & Ilford. Our project, to have a Cat 6 BWT available at Capertee RFS to support the other brigades in the district, to better equip the district in the event of further bushfires, will encourage not only economic growth of business to the area, but it will also be very beneficial in providing confidence & resilience to current & future residents of our local community. Capertee & District Progress Assoc. has been working towards promoting the district for tourism & as an attractive area to live since the current committee were elected, some 7 years ago. We see the strengthening of the resources of the local RFS brigade as a very important part of attracting business, residents & tourism to the area. People want to feel that they are protected, the Cat 6 BWT forms an integral part of that confidence.

The Capertee RFS has been asking for a large bulk water tanker for approximately 7 years. With increased traffic along the Castlereagh highway, being the road from Lithgow LGA to the Central West, Mudgee, and increasing people moving from Sydney to our district, it has also put more pressure on RFS responses to accidents. The introduction of the Cat 6 BWT will provide increased immediate support to meet these events. In our support attachments there is an article about the Brian James motor vehicle accident death. This triggered immediate community support, and from this the Capertee RFS secured \$3500 in trust for the purchase of a Cat 6 BWT. I have also previously mentioned in our application for the grant for the BWT, the dreadful housefire on 14/04/2018, which claimed the life of a small child.

We may appear to be a small community, but the Capertee district spans a huge area & encompasses a great many people, property, livelihoods &

livestock. The edge of the Gosper's Mountain Fire was frighteningly visible from our landscape every night. Homes and lives were at risk all around our district, cutting off communities, causing panic with our residents. One outbreak, on Crown Station Road, just outside Capertee, threatened to take out the entire valley & everything in its pathway. Because of a lack of available water, through previous droughts, dry dams & little water in tanks, the RFS refilled from a semi-trailer provided by Lithgow Council. As it couldn't travel to the fireground, RFS units had to leave the fireground to re-fill, which took some 1 to 1.5 hours. Within than time, the fire front had progressed an incredible 2 kms onto people's properties. Some residents left, some couldn't, others had no where to go if they did leave. It was a horrific experience.

The 2019/2020 summer bushfires taught us a great many things. The main thing was a need to be able to better equip our firefighters with the equipment they need on the ground, here, now, and having a fully functional fire-fighting bulk water tanker on hand is essential, the need to become more resilience, for the future. This is why Capertee & District Progress Association have put forward this grant application. We see that through improving our local RFS resources, we can move forward & recover confidence, and encourage economic growth, tourism & continue to encourage regional population growth to our area.

As mentioned, we have the full support of Andrew Gee MP & Tony Abbott, who were both supporting our RFS during the 2019/2020 Black Summer Bushfires.

Mourners of former Rabbitohs player help community get new fire truck

At the height of the recent bushfire season, the Capertee Rural Fire Service found itself in a unenviable position — fighting fires with little to no water.

The brigade, based in the New South Wales
Central West, had made an impassioned plea for
money to buy a new tanker, but the funding that
would help pay for it would come from an
unexpected and tragic event.

Brian James, a former Rabbitohs player and life member of the club, moved to the Capertee Valley with his wife, Elizabeth, about three years ago.

He was passionate about trying to help the local

RFS get its new truck, especially after watching the crews protect his property and others.


When he died in a farming accident earlier this year, his family asked mourners to donate to the Capertee brigade in lieu of flowers.

"It means so, so much to the brigade and neighbouring brigades," Capertee RFS Captain Steve Dalli said.

Elizabeth James said the firefighters worked tirelessly to protect them and their neighbours.

"They just worked, Steve and the crew, worked constantly day and night without sleep. How can you repay that?" she said.

Mrs James said her late husband would have been happy to have helped, and that her family was grateful to the RFS for more than just fighting fires.

The local crew were also the first responders to the accident which took Brian James' life.

"The local RFS were the first people to get here and to help him and to order the helicopter that took him to Liverpool emergency," Mrs James said.

She said the support had not stopped, despite the fires being out and the donations from her husband's funeral finalised.

"The local people have come to chop wood for me. I have had help with the solar energy," Mrs James said.

"They are amazing, and it is such a shame we can't catch up with them because of COVID-19 more frequently."

The type of truck and final amount of donations was not confirmed by the Rural Fire Service, but a spokesman told the ABC the process to order the vehicle had begun.

I'm writing in support of the Capertee Progress Association's application for a bushfire recovery grant towards the purchase of a Category 6 Bulk Water Tanker for the Capertee RFS.

As you might recall, after I'd spoken to the local RFS captain, ^{s 22(1)(a)(ii)} I raised this with you in January last year at the height of the Black Summer fire season, and it's good that you and your office are now trying to steer this forward.

Back then, I'd been on a three day RFS deployment to Glen Davis, not far from Capertee. Nearly all firefighting water had to be trucked in by contracted semi-trailers as the dams were dry and there was no readily available town water. A purpose-built Cat 6 Tanker would have been so much more useful and made fire fighting operations so much more effective because it could have gone to the fire front. Instead, fire fighting vehicles had to leave the fire line to rendezvous with the contract semis that couldn't navigate fire trails or go off-road. This sometimes was an hour turn-around at perilous times.

Because of the large area that the Capertee brigade covers, and the distance from other similar vehicles in Lithgow, Bathurst or Mudgee, a Cat 6 Tanker at Capertee would be an important addition to effective fire-fighting in the region.

I very much hope that this grant can urgently be processed and approved.

I write in support of the application by Capertee and District Progress Association Incorporated for funding under the Black Summer Bushfire Recovery Grants Program for the purchase of a Category 6 Bulk Water Tanker to be based in Capertee, for use by local RFS Brigades in times of fire and other emergencies.

I understand that the funding would enable community members of Capertee, in the Lithgow Local Government Area, to purchase a Category 6 Bulk Water Tanker that will provide critical firefighting and emergency responses that are currently unmet in the wider Capertee, Glen Alice and Ilford communities. The bulk water carrier will assist in addressing the social and economic recovery and resilience of residents and businesses directly and severely affected by the Black Summer Bushfires of 2019/2020.

There can be no doubt that a Bulk Water Tanker would also be a vital piece of infrastructure that will enable the communities to adequately protect their residents and visitors, as well as existing infrastructure, to ensure the district can continue to economically prosper and safely attract new residents and tourists.

I was in Capertee during the Black Summer Bushfires and witnessed first-hand the dire need for a locally owned and based Category 6 Bulk Water Tanker. Fire fighters in the remote community of Capertee rely on finite tank water to fill vital firefighting units. Once tanks ran dry during the Black Summer Fires, crews were left at the fire front without water. Not only were volunteers, surrounding properties and livestock put at risk, the fire was able to spread several kilometres. This compromising scenario played out on several occasions.

A small, borrowed water tanker was brought in to assist, but it was unable to traverse the rugged bushland, which meant fire fighting units were forced to leave the unrelenting fireground to refill their vehicles.

A community-owned Category 6 Bulk Water Tanker holds 9,000 litres of water; enough to fill six to eight fire trucks at a fire front. Such an asset would ensure fire fighters and fire trucks wouldn't need to leave the fireground to refill. The Bulk Water Tanker is also capable of carrying firefighting equipment and two crew.

A locally owned and based Bulk Water Tanker would equip the local community with a critical resource it urgently needs to fight all future bush fires, as well as allow for an adequate local response to motor vehicle accidents on the Castlereagh Highway which links Mudgee with Lithgow, the Blue Mountains and Sydney.

As a volunteer firefighter myself, I understand the urgent need for such an essential resource. I think it is commendable that the application is for a community-led recovery. The drive among all community members to secure a water tanker has been very strong and the wider community has itself invested significant time and effort in the fight for such a resource.

I understand that Capertee and District Progress Association Incorporated can provide the necessary governance and project management structures for this critical project.

It is for these reasons that I strongly support the application by Capertee and District Progress Association Incorporated and wish it every success.

Nice to catch up yesterday.

I understand that in discussions with the A/District Manager s 22(1)(a)(ii) , the brigade would now consider a Category 6 tanker. The key difference between a Category 6 and a Category 13, is that the Cat 13 is purely a logistics appliance used for carrying 11,000 litres of water as against a Cat 6 which has a 9,000 litre capacity as well as being a firefighting appliance. The Cat 6 was designed and introduced some 5 years ago with grassland firefighting in mind as it can be operated by 2 people, has a monitor on the front and if used as bulk water can still fill 3 of our basic bread and butter fire appliances the Cat 1.

Given that your brigade area has both grasslands and forested lands this may be a better option and I have had discussions to understand its more supported by the Senior Management Team than the single purpose appliance (Cat 13). You should expect though that a Cat 6 firefighting appliance will be requested to assist other brigades more often as they have proven their worth in matters such as truck fires on major arterial roads and the protection of exposures in well involved structure fires.

As discussed, both vehicles are built on the same chassis and simply have a different operating platform so in terms of size and dimension, they would be the same. I have attached a Category 6 brochure for your information, although I think there was one attached in our original correspondence.

Cat 6 firefighting appliances of the latest version as per the attached spec are in service at Hunter Valley (Muswellbrook), Canobolas (Canobolas Support Brigade), Cudgegong (Mudgee HQ) and Central Coast (Wyong Operational Support Brigade). There are others but these are the closest to your Brigade location. I am happy to facilitate visits should your brigade seek to do so.

There is a price difference as the Cat 6 is around \$435,000. (i) This reflects the additional firefighting equipment, tanker protection etc. Obviously whilst I am here to facilitate it is important that there is general agreement both amongst the brigade and the Chifley Lithgow Senior Management Team, I know you have had discussions with some and will continue that and for transparency I have copied him into this mail.

Let me know how you would like to proceed.

(i) — As you will note from the information that was given by the RFS Senior Assistant Commissioner, s 22(1)(a)(ii) , 18 months ago, the cost was estimated as being \$435,000 at that point of time. Note: Estimate. We have allowed for an additional cost of \$65,000 in our grant application, allowing for inflation & the need for the CAT 6 BWT to be transported from Sydney to Capertee.

If we are successful in our application for the grant, we will be in a position to submit a formal request for a quote from the RFS, which we will then be able to forward to the portal. We didn't want to find ourselves in a situation that we didn't quite have enough to purchase the CAT 6 BWT if we only applied for the amount guesstimated in this email.

If the cost of the CAT 6 BWT is less than we have estimated in our grant application, we will of course adjust our application accordingly.

- (ii) We have been advised that it takes 2 years from the date of order to the date of delivery of the Cat6 BWT to the Capertee RFS. We would of course place our order as soon as funds are made available from the grant funding.
- (iii) s 22(1)(a) (RFS Captain Capertee) will be following up on the progress of the engineering, and providing updates to s 22(1)(a)(ii) (Secretary Capertee & District Progress Association Inc.) so they can be provided to the grant body via the portal.
- (iv) There is no Risk Assessment plan required, as all the RFS Engineering takes care of the build of the CAT 6 BWT, and all RFS Capertee members who will have access to the tanker will be trained in its use prior to the tanker becoming utilized.
