The Hon David Crisafulli is Queensland's 41st Premier. He has been the State Member for Broadwater (Gold Coast) since 2017.

Premier Crisafulli was born and raised in Queensland. He obtained a Bachelor of Journalism from James Cook University in Townsville in 2000, becoming a journalist with WIN News and working as a correspondent for The Australian and Sunday Mail newspapers. Premier Crisafulli entered politics in 2004 via the Townsville City Council, before being elected to the Queensland Government in 2012 in the seat of Mundingburra (Townsville).

Northwest Queensland Minerals Province

- Northwest Queensland's mineral deposits include those used in electric and hybrid vehicles, batteries, wind turbines and solar panels. These are:
 - Copper, zinc, and phosphorus, which are on the Strategic Materials List, and vanadium, which is on the Critical Minerals List, and lead and silver.
 - Demand for these metals is expected to outstrip supply significantly between 2030 and 2040.
 - Phosphate and vanadium are not currently mined, but there are mining projects under development to produce them.

Renewable Energy and Copperstring

- Copperstring 2032 is a major transmission line project that will connect Northwest Queensland to the National Electricity Market, reducing energy costs and reliance on gas.
- It will enable new renewable energy projects—like solar and wind farms—to connect to the grid, supporting regional development from Mount Isa to Townsville.

- The Port of Townsville has been the economic cornerstone of north Queensland since it began trading in 1864. It is the country's biggest exporter of sugar, zinc, copper and lead.
