Question	Response
1. What countries do measures apply to?	<p>On 23 April 2021, provisional anti-dumping measures in the form of dumping securities (DSA) and countervailing securities (CSA) were imposed on Painted Steel Strapping exported from the People’s Republic of China (China).</p> <p>For more information please refer to SEF 553 and Anti-Dumping Notice 2021/056</p>
2. What types of painted steel strapping are subject to provisional anti-dumping measures?	<p>The ‘description of goods’ subject to securities include:</p> <ul style="list-style-type: none"> • Painted steel strapping, of carbon steel, whether or not in coils, whether or not waxed, with a nominal width of 12 mm to 32 mm, a nominal thickness of 0.5 mm to 1.5 mm. <p>The following descriptions are <i>excluded</i> from measures, exemption type “GOODS” applies:</p> <ul style="list-style-type: none"> • Stainless steel strapping and galvanised steel strapping are excluded from the goods. <p>For more information about the description of the goods subject to securities, please refer to the SEF 553 for the investigation.</p> <p><u>Please Note:</u></p> <ol style="list-style-type: none"> 1. When importing goods into the country importers are required to self-assess whether the imported goods meet the goods description outlined above and whether anti-dumping measures apply. 2. The Anti-Dumping Commission is not in a position to provide advice on whether certain goods meet the description above. 3. The use of exemption types is subject to monitoring by the Anti-Dumping Commission (the Commission) and Australian Border Force (ABF).

<p>3. How much Dumping Securities (DSA)/ Countervailing Securities (CSA) will an importer have to pay?</p>	<p><u>DSA – all exporters (except Qinhuangdao Jiashilun Packaging Material Co Ltd)</u> DSA is in the form of an ad valorem measure. The total DSA liability is calculated by multiplying the dumping export price (DXP) by the applicable DSA ad valorem duty rate.</p> <p><u>CSA – all exporters</u> The CSA liability is calculated by multiplying the DXP by the CSA ad valorem duty rate.</p>
<p>4. Example of how to calculate the Dumping Securities (DSA)/ Countervailing Securities (CSA) liability</p>	<p>Ad Valorem measures</p> <p>The following is an example of how to calculate the DSA/CSA liability.</p> <ul style="list-style-type: none"> • DXP = AUD \$1,000 (Free-On-Board (FOB), cash) • DSA ad valorem rate = 10% • CSA ad valorem rate = 15% <p>Total DSA liability DXP (\$1,000) multiplied by the DSA ad valorem rate (10%) = \$100</p> <p>Total CSA liability DXP (\$1,000) multiplied by the CSA ad valorem rate (15%) = \$150</p>

5. What is the dumping export price (DXP) and how do I calculate it?

The DXP refers to the actual export price of the exported goods. The DXP should reflect the total export (invoice) price of the goods being entered, not the unit price of the goods.

The DXP should be recorded on the relevant Full Import Declaration for the goods in the same terms as the AEP for the goods. Calculating the DXP may involve adjusting the actual export invoice price of the goods to the terms specified for the AEP.

For example, if the AEP terms are “FOB, cash” and the actual invoice terms of the goods are “CIF, 60 days, packed”, the following adjustments will need to be made in order to calculate the DXP at FOB, cash level.

- step 1 - an adjustment for interest on credit terms will need to be made; and
- step 2 - the overseas freight and insurance components will need to be subtracted from the export invoice price.

Where suitable evidence cannot be proffered by the importer of the interest rate, then 1.0% per month (0.033% per day) should be applied to the actual invoice price credit terms.

An example of adjusting for credit and incoterms is provided below:

- Invoice terms = CIF, 60 days
- Specified terms = FOB, cash
- Export price - invoice amount = \$1,000
- Marine insurance and ocean freight amount = \$100

Step 1 - adjust for credit terms

1. 1% per month interest rate should be applied to the invoiced price credit terms (i.e. 30 days = 1%)
2. If the invoiced CIF, 60 days price is \$1,000, then the CIF, cash price = \$980 (\$1,000 less 2%)

Step 2 - adjust for incoterms

3. Adjust for freight and insurance to calculate DXP at FOB, cash equivalent
4. CIF, cash price of \$980 minus freight and insurance amount of \$100 = \$880
5. The DXP price = \$880 FOB, cash

What information is needed to complete an import declaration for goods subject to securities?</p>	<p>The information required by an importer or Customs broker to complete an import declaration for goods subject to CSA/DSA is:</p> <ul style="list-style-type: none"> • DXP; • Dumping Specification Number (DSN) or exemption type (where appropriate); • Country (this is usually country of origin or export country); • Tariff classification and statistical code; • Exporter / supplier; and • Quantity. <p>Please see below to determine which DSN applies to the exporter of your goods.</p>																												
<p>7. Will dumping securities collected on my imports be converted to measures?</p>	<p>Securities taken will be either cancelled or converted to IDD/ICD after the Minister's decision at the completion of the investigation.</p> <p>The ABF will contact each affected importer/broker and provide relevant cancellation and/or conversion instructions for each consignment subject to securities.</p>																												
<p>8. How do I lodge an entry for goods subject to dumping security?</p>	<p>Goods subject to DSA/CSA, must be entered using the DSN shown below.</p> <p>Importers/brokers will need to complete and submit a dumping security undertaking form when lodging an entry for goods subject to these measures. Importers and Customs brokers should contact the National Temporary Imports and Securities section of the Australian Border Force at ntis@abf.gov.au to request and lodge the undertaking form and for further information relating to the operation of securities.</p>																												
<p>9. Are there any exporters exempt from anti-dumping securities?	<p>All exporters and suppliers of painted steel strapping from China are subject to CSA and DSA except for Qinhuangdao Jiashilun Packaging Material Co Ltd.</p> <p>The 'all other exporters' rate of DSA/CSA will apply to exported goods unless an importer has evidence that the goods are being supplied either directly by a named exporter or through a linked supplier.</p>				
11. How long are the securities in place for?	<p>Securities are in place until the conclusion of the investigation.</p>				
12. What tariff classifications and statistical codes are covered by the anti-dumping securities?	<p>Goods are generally, but not exclusively, classified to the tariff classifications and associated statistical codes below:</p> <table border="1" data-bbox="714 579 1373 668"> <thead> <tr> <th data-bbox="719 582 1070 632">Tariff Classification</th> <th data-bbox="1075 582 1368 632">Statistical code</th> </tr> </thead> <tbody> <tr> <td data-bbox="719 635 1070 665">7212.40.00</td> <td data-bbox="1075 635 1368 665">62</td> </tr> </tbody> </table> <p>These tariff classification numbers may apply to goods which are not subject to measures, may change because of amendments to the Working Tariff, or the subject goods may be imported under tariff classification numbers that are not listed.</p> <p>The listing of this tariff classification and statistical code is for convenience or reference only and does not form part of the goods description.
