Question	Response
1. What countries do measures apply to?	<p>Measures currently apply to goods from the People’s Republic of China (China).</p> <p>On 16 April 2014, anti-dumping measures in the form of interim dumping duties (IDD) were imposed on wind towers exported from the People’s Republic of China (China) and the Republic of Korea (Korea). For more information please refer to the Final Report <a href="#">REP 221</a> and Anti-Dumping Notice <a href="#">2014/33</a>.</p> <p>On 25 March 2019, with an effective date of 17 April 2019, anti-dumping measures in the form of IDD were varied on wind towers exported from the China following a continuation inquiry. On 16 April 2019, anti-dumping measures in the form of IDD on wind towers from Korea expired. For more information please refer to the Final Report <a href="#">REP 487</a> and Anti-dumping Notice <a href="#">2019/33</a></p>
2. What types of wind towers are subject to anti-dumping measures?	<p><b>The goods subject to measures include:</b></p> <ul style="list-style-type: none"> <li>• Certain utility scale wind towers, whether or not tapered, and sections thereof (whether exported assembled or unassembled), and whether or not including an embed being a tower foundation section.</li> <li>• Wind turbines that have electrical power generation capacities equal to or in excess of 1.00 megawatt (MW) and with a minimum height of 50 metres measured from the base of the tower to the bottom of the nacelle (i.e. where the top of the tower and nacelle are joined) when fully assembled.</li> <li>• A wind tower section consists of, at a minimum, multiple steel plates rolled into cylindrical or conical shapes and welded together (or otherwise attached) to form a steel shell, regardless of coating, end-finish, painting, treatment or method of manufacture, and with or without flanges, doors, or internal or external components (e.g., flooring/decking, ladders, lifts, electrical junction boxes, electrical cabling, conduit, cable harness for nacelle generator, interior lighting, tool and storage lockers) attached to the wind tower section.</li> </ul> <p><b>The following descriptions are <i>excluded</i> from measures, exemption type “GOODS” applies:</b></p> <ul style="list-style-type: none"> <li>• Nacelles and rotor blades, regardless of whether they are attached to the wind tower.</li> <li>• Any internal or external components which are not attached to the wind towers or sections thereof.</li> </ul> <p><a href="#">Ministerial Exemption Instrument No 2 of 2018</a></p> <p>IDD does not apply to goods subject to <a href="#">Tariff Concession Order (TCO) 1761480</a> with an effective date of 21 September 2017.</p> <ul style="list-style-type: none"> <li>• Base section of a five section Wind Generator Tower, having all of the following: <ul style="list-style-type: none"> <li>○ Plate steel having a thickness of NOT less than 33mm and NOT greater than 60mm;</li> <li>○ Section length NOT less than 14,100mm and NOT greater than 16,250mm;</li> <li>○ Section weight NOT less than 60 metric tonnes and NOT greater than 105 metric tonnes; and</li> <li>○ Diameter NOT less than 4,299mm and NOT greater than 4,650mm.</li> </ul> </li> </ul>

<p>2. What types of wind towers are subject to anti-dumping measures? (continued)</p>	<p><a href="#">Ministerial Exemption Instrument No 5 of 2018</a></p> <p>IDD does not apply to goods subject to <a href="#">Tariff Concession Order (TCO) 1813104</a> with an effective date of 16 May 2018.</p> <ul style="list-style-type: none"> <li>• Second section from bottom of a five section Wind Generator Tower, having ALL of the following: <ul style="list-style-type: none"> <li>○ Plate steel having a thickness of NOT less than 30 mm and NOT greater than 60 mm;</li> <li>○ Section length NOT less than 15 500 mm and NOT greater than 22 000 mm;</li> <li>○ Section weight NOT less than 80 metric tonnes and NOT greater than 120 metric tonnes;</li> <li>○ Outer diameter NOT less than 4 400 mm and NOT greater than 4 900 mm</li> </ul> </li> </ul> <p>For more information about the description of the goods subject to measures, please refer to the Final Report <a href="#">REP 221</a></p> <p><b>Please Note:</b></p> <ol style="list-style-type: none"> <li>1. When importing goods into the country importers are required to self-assess whether the imported goods meet the goods description outlined above and whether anti-dumping measures apply.</li> <li>2. The Anti-Dumping Commission is not in a position to provide advice on whether certain goods meet the description above.</li> <li>3. The use of exemption types is subject to monitoring by the Anti-Dumping Commission (the Commission) and Australian Border Force (ABF).</li> </ol>
<p>3. How much interim dumping duties (IDD) will an importer have to pay?</p>	<p><b><u>IDD – all exporters (except Shanghai Taisheng Wind Power)</u></b></p> <p>IDD is in the form of an ad valorem measure. The total IDD liability is calculated as the dumping export price (DXP) multiplied by the applicable IDD ad valorem duty rate.</p>
<p>4. Example of how to calculate the interim dumping duties (IDD) liability</p>	<p><b><u>Ad Valorem Measure</u></b></p> <p>The following is an <b>example</b> of how to calculate the IDD liability.</p> <ul style="list-style-type: none"> <li>• DXP = AUD \$1,000 (Free-On-Board (FOB), cash)</li> <li>• IDD ad valorem rate = 10%</li> </ul> <p><b>Total IDD liability</b></p> <p>The DXP (\$1,000) multiplied by the IDD ad valorem rate (10%) - \$1,000 x 10% = \$100</p>
<p>5. What is the dumping export price (DXP) and how do I calculate it?</p>	<p>The DXP refers to the actual export price of the exported goods. The DXP should reflect the total export (invoice) price of the goods being entered, not the unit price of the goods.</p> <p><b>The DXP should be recorded on the relevant Full Import Declaration for the goods in the same terms as the export price terms for the goods. Calculating the DXP may involve adjusting the actual export invoice price of the goods to the terms specified.</b></p>

<p>5. What is the dumping export price (DXP) and how do I calculate it? (continued)</p>	<p>For example, if the export price terms are “FOB, cash” and the actual invoice terms of the goods are “CIF, 60 days, packed”, the following adjustments will need to be made in order to calculate the DXP at FOB, cash level.</p> <ul style="list-style-type: none"> <li>• step 1 - an adjustment for interest on credit terms will need to be made; and</li> <li>• step 2 - the overseas freight and insurance components will need to be subtracted from the export invoice price.</li> </ul> <p>Where suitable evidence cannot be proffered by the importer of the interest rate, then 1.0% per month (0.033% per day) should be applied to the actual invoice price credit terms. An example of adjusting for credit and incoterms is provided below:</p> <ul style="list-style-type: none"> <li>• Invoice terms = CIF, 60 days</li> <li>• Specified terms = FOB, cash</li> <li>• Export price - invoice amount = \$1,000</li> <li>• Marine insurance and ocean freight amount = \$100</li> </ul> <p><b>Step 1 - adjust for credit terms</b></p> <ol style="list-style-type: none"> <li>1. 1% per month interest rate should be applied to the invoiced price credit terms (i.e. 30 days = 1%)</li> <li>2. If the invoiced CIF, 60 days price is \$1,000, then the CIF, cash price = \$980 (\$1,000 less 2%)</li> </ol> <p><b>Step 2 - adjust for incoterms</b></p> <ol style="list-style-type: none"> <li>3. Adjust for freight and insurance to calculate DXP at FOB, cash equivalent</li> <li>4. CIF, cash price of \$980 minus freight and insurance amount of \$100 = \$880</li> <li>5. The DXP price = \$880 FOB, cash</li> </ol>
<p>6. What information is needed to complete an import declaration for goods subject to measures?</p>	<p>The information required by an importer or Customs broker to complete an import declaration for goods subject to IDD is:</p> <ul style="list-style-type: none"> <li>• DXP;</li> <li>• Dumping Specification Number (DSN) or exemption type (where appropriate);</li> <li>• Country (this is usually country of origin or export country);</li> <li>• Tariff classification and statistical code;</li> <li>• Exporter / supplier; and</li> <li>• Quantity.</li> </ul> <p>Please see below to determine which DSN applies to the exporter of your goods.</p>

<p>7. Are there any exporters exempt from anti-dumping measures?</p>	<p>All exporters and suppliers of wind towers from China are subject to IDD except Shanghai Taisheng Wind Power.</p> <p>The ‘all other exporters’ rate of IDD will apply to exported goods unless an importer has evidence that the goods are being supplied either directly by a named exporter or through a linked supplier.</p>																																					
<p>9. How long are the measures in place for?</p>	<p>The measures have been imposed for five years, unless revoked earlier.</p> <p>In the case of wind towers from China, the measures are in place until 16 April 2024.</p>																																					

<p>10. Please refer to the goods description for authoritative detail regarding goods subject to measures.</p> <p>Where importers are unclear on the correct tariff classification of their goods, it is recommended they check the <a href="#">Working Tariff page</a> on the ABF website or contact the ABF on 131 881.</p>								

11. What are the duty assessment importation and application period dates?

An importer of goods on which an IDD has been paid, may lodge an application with the Commissioner requesting that the Parliamentary Secretary make an assessment of the final liability of those goods to duty.

This usually occurs when an importer considers that the IDD paid in respect of goods exceed the total amount payable (i.e. importers consider they are entitled to a refund of duties). In relation to IDD, an importer may consider that the dumping margin for the goods is now less than it was during the investigation period, or that its exporter is no longer dumping, and as a result it has paid more duty than it should have paid.

There are a series of time frames fixed by legislation that govern the duty assessment system (referred to as importation periods). The duty assessment importation periods and application dates for wind towers from China and Korea are as follows:
