



ANTI-DUMPING NOTICE NO. 2014/79

Prepared or Preserved Tomatoes Exported from Italy by Coppola Foods Ltd Accelerated Review

Customs Act 1901 – Part XVB

I, Dale Seymour, the Commissioner of the Anti-Dumping Commission, have commenced an accelerated review of the anti-dumping measures applying to prepared or preserved tomatoes exported to Australia from Italy, in so far as they relate to a new exporter Coppola Foods Ltd (Coppola).

The lodgement date of 28 July 2014 is the commencement date of the accelerated review.

The Goods

The goods subject to anti-dumping measures, in the form of a dumping duty notice, are prepared or preserved tomatoes (the goods).

The applicant provided further details as follows:

Tomatoes, whether peeled or unpeeled, prepared or preserved otherwise than by vinegar or acetic acid, either whole or in pieces (including diced, chopped or crushed) with or without other ingredients (including vegetables, herbs or spices) in packs not exceeding 1.14 litres in volume.

Excluded from the goods are:

Pastes, purees, sauces, pasta sauces, juices and sundried tomatoes.

The goods are currently classified to the tariff subheading 2002.10.00 (statistical code 60) of Schedule 3 to the *Customs Tariff Act 1995*. These goods exported from Italy are subject to 5% Customs duty.

Existing measures

The anti-dumping measures were initially imposed by public notice on 16 April 2014 by the Parliamentary Secretary to the Minister for Industry (Parliamentary Secretary) following consideration of the Anti-Dumping Commission Report No. 217 (REP 217). These measures are applicable to all exporters from Italy except La Doria S.p.A. and Feger di Gerardo Ferraioli S.p.A.

The dumping duty that had been determined was an amount worked out in accordance with the combination of fixed and variable duty method.

The current review

On 28 July 2014, Coppola lodged an application under s.269ZF of the *Customs Act 1901* (the Act) for an accelerated review of the dumping duty notice in relation to the goods exported to Australia from Italy by Coppola.

Following consideration of the application, I have decided not to reject the application. Further detail on the consideration of the application is contained in the Anti-Dumping Commission's (the Commission's) *Consideration Report Number 260* (CON 260).

Having regard to the expedited nature of an accelerated review, the Commission considers that it is not the relevant mechanism to reassess certain aspects of the anti-dumping measures applying to prepared or preserved tomatoes. This accelerated review will not reassess the finding of whether or not a market situation exists such that sales in that market are not suitable for use in determining normal value as specified in REP 217.

After concluding the accelerated review, a recommendation will be made to the Parliamentary Secretary that the dumping duty notice, in respect of Coppola:

- i. remain unaltered; or
- ii. be altered so as not to apply to the applicant; or
- iii. be altered so as to apply to the applicant as if different variable factors had been fixed.

If recommending to the Parliamentary Secretary that different variable factors be applied to the applicant, I may propose a change in the method to determine the duty. The amount could be worked out in accordance with the combination of fixed and variable duty method, the floor price duty method, the fixed duty method or the ad valorem duty method.

Public Record

There is no legislative requirement to maintain a public file for accelerated reviews. However, in the interests of transparency, a public file for this accelerated review has been opened and may be examined at the Anti-Dumping Commission's office by contacting the case manager on the details provided below. Alternatively, the public record is accessible at www.adcommission.gov.au.

The public record will contain, among other things, a copy of the application, the consideration report, and submissions from interested parties.

Securities

I have made a declaration under paragraph 269ZH(b) to ensure securities are taken for the period of the review in respect of interim dumping duty that may be payable on importation of prepared or preserved tomatoes for the period of the review. The effective rate of duty has been determined in accordance with the combination of fixed and variable duty method.

Lodgment of submissions

Interested parties, as defined by subsection 269T(1) of the Act, are invited to lodge written submissions concerning the accelerated review no later than the close of business on

Interested parties wishing to participate in the accelerated review must ensure that submissions are lodged promptly. Interested parties should note that I am not obliged to have regard to a submission received by the Commission after the date mentioned above if to do so would, in my opinion, prevent the timely preparation of the report to the Parliamentary Secretary.

Interested parties claiming that information contained in their submission is confidential, or that the publication of the information would adversely affect their business or commercial interests, must:

- (i) provide a summary containing sufficient detail to allow a reasonable understanding of the substance of the information that does not breach that confidentiality or adversely affect those interests, or
- (ii) satisfy me that there is no way such a summary can be given to allow a reasonable understanding of the substance of the information.

Submissions containing confidential information must be clearly marked "FOR OFFICIAL USE ONLY".

Interested parties must lodge a non-confidential version, or a summary of their submission, in accordance with the requirement above (clearly marked "PUBLIC RECORD").

Report to the Parliamentary Secretary

Submissions received by 26 September 2014 will be taken into account in preparing the report and recommendations to the Parliamentary Secretary. A recommendation to the Parliamentary Secretary will be made in a report on or before 5 November 2014, (or such later date as the Parliamentary Secretary may allow).
