
To evidence this we have attached a copy of Amoor's letter of 18 February 2013 notifying customers of the phased shut-down of its Australian cartonboard production plant during the second half of this year.

The closure of Amcor's cartonboard production plant will mean that there is no longer an Australian industry producing like goods to the grey cartonboard from Korea to which current anti-dumping measures apply and therefore these anti-dumping measures should be revoked.

Amcor Cartonboard - Petrie Mill closure

Amon today released its results for the half-year ending 30 December 2012; which included notification of the impending closure of the Amoor Cartonboard Milliat Petrie in Queensland.

The Petrie Mill is trade exposed and despite the best efforts of the management and workforce to improve revenue; reduce costs and manage cash flow, the business has now reached the point where it is technically impaired. Amoor sees little prospect that either costs will abate or market conditions will change to the extent required to return the mill to profitability into the foreseeable future.
