1) Status of New Exporter

1.1. Background

1.1.1. Le Specialità Italiane Srl have to be considered according to Section 269T as a new exporter, because the company never before did export Prepared and/or Preserved Tomatoes to Australia.

1.1.2. Based on Subsection 269ZE (1) the company applies for an accelerated review in manner to be authorised to export prepared and preserved Tomatoes to Australia.

1.2. Application

Specialità Italiane Srl has during the period from 1 July 2012 and till today July 14<sup>th</sup>, 2014 never exported prepared or preserved tomatoes to Australia.

1.3. Relationships with selected exporters

Specialità Italiane Srl is working on his own as a fully independent factory, having around 250 own workers. The industrial building is rented.

1.4. Products to be exported:

- Chopped tomatoes: Sizes: 12x400g (drained weight 240g – nominal weight 425ml), 24x400g (drained weight 240g – nominal weight 425ml), 12x800g (drained weight 480g – nominal weight 850ml), 6x2550g (drained weight 1530g – nominal weight 2650ml)
- Peeled tomatoes: Sizes: 12x400g (drained weight 240g – nominal weight 425ml), 24x400g (drained weight 240g – nominal weight 425ml), 12x800g (drained weight 480g – nominal weight 850ml), 6x2550g (drained weight 1530g – nominal weight 2650ml)
- Organic Double tomato paste: Sizes: 24x140g (nominal weight 142ml), 50x140g (nominal weight 142ml)
- Mashed tomatoes in bottle: Size: 12x690g (nominal weight 720ml)

1.5. The prices of the exported products will be considered in the range of the prices operated by competitors and conform to the prices quoted on the export market (Germany, Austria, etc.)

1.6. Specialità Italiane Srl exports its products also to other countries like Germany, Austria.

1.7. Specialità Italiane selects its suppliers of tomatoes starting from the selection of the seeds, the follow up of the cultivation and controlling the harvest to guarantee a high quality of the basic raw material (tomatoes).

Specialità Italiane has a laboratory where the production is constantly tested to grant the highest quality of the final product.

The equipment for the treatment of the tomatoes is conform to the latest requirement of the food industry, requesting highest hygienically procedures.

2) The applicant is ready to cooperate in relation to the application for a dumping duty notice and to fulfil whatever request from the administration presenting the whole documentation about price calculation (questionnaire) etc.

3) Therefore the accelerated review may be sought because:

3.1. the applicant never exported tomatoes products to Australia.

3.2. The applicant didn't refuse to cooperate to the application for a dumping duty notice.

3.3. the applicant does not appear to be related to any selected exporter.
