3. Orica's interest as an affected party.

Orica Australia Pty Ltd is involved in the importation of sodium bicarbonate from the Peoples Republic of China into Australia. The imported product is supplied into the Australian stock feed market for use primarily in chicken and cattle (dairy and meat) feed.

4. Reasons for revocation of measures:

The administrators appointed for the only Australian manufacturer of sodium bicarbonate, Penrice Soda Holding Ltd, announced on the 24<sup>th</sup> of June 2014 that the Penrice Osborne chemical plant will cease operation effective immediately (please see attached ASX announcement). The Penrice Osborne (South Australia) chemical plant is the only Australian or South East Asian operation that has been producing sodium bicarbonate in recent history (please see Penrice company overview: http://www.penrice.com.au/).

Following the closure of the Penrice Soda Holdings operations at the Osborne site there is no current injury to Australian industry, and there is unlikely to be a recurrence of injury if the measures were to be revoked. A competitive price for sodium bicarbonate will benefit the local agricultural industry.

I refer to the appointment of joint and several Administrators to PSH on 11 April 2014.

The Administrators of PSH announced today that following the withdrawal of the preferred bidder from the sale process, Penrice's Osborne chemical plant will cease operations effective immediately. The Administrators are currently seeking alternative strategies to realise residual value from the Osborne plant.

The Administrators have received final offers for Penrice's limestone quarry in Angaston and will continue negotiations with bidders over the coming days in an effort to conclude a sale contract. The Angaston quarry will continue operations during the intervening period.
