Re: Review of Anti-Dumping Measures on Certain Aluminum Extrusions (Anti-Dumping Notice 2014/46)

To Whom it May Concern,

On behalf of our client Anvil Industrial Doors and their Supplier Huzhou Dulun Metal Products Co.,Ltd we hereby seek to have the supplier Huzhou Dulun Metal Products Co.,Ltd assessed under the current initiation of a Review into Anti-Dumping measures on Aluminium extrusions.

Our client has only imported extrusions from this manufacturer in China since 2012, all of their importations initially being outside of the original period under investigation which was under ACDN 2009/20 (Trade Measures Case 148) whereby this assessed imports between the period of 1 July 2008 – 30 June 2009, subsequently there has been additional Trade Measures Case 175 which further reviews exports from China also outside of the period in which our client imported aluminium extrusions.

The first shipment from this supplier was in early August 2012 outside of the original investigation period. Three further imports occurred in late August, October and November 2012 where duty was calculated on the goods with a combined dumping and countervailing duty of 22.4% as the supplier is under the current heading of All other Exporters due to not having being assessed for review of measures previously.

The importer has worked with the supplier to provide aluminum parts to be manufactured into Roller Doors here in Western Australia at their manufacturing facility using their own Die which was purchased and currently kept at the manufacturer for orders placed by Anvil for roller door stock.

Anvil Industrial Doors is a local company, owned and operated in Western Australia and produces a high quality garage door for both Industrial and Private sectors. They are looking at new products however with the current Trade Remedies imposed on ALL importers, they have had to review their entire operation. They had previously purchased extrusions from local producer however they were aware that these extrusions were imported products at a cost higher than what they had previously paid to the supplier for the products leading to their decision to source their own product at a price comparable to what they had previously paid with the local supplier.

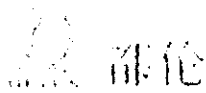

Aluminium Extruded Products from China

Dear Sirs,

Huzhou Dulun Metal Product Co Ltd (Dulun) is a private limited liability company that manufactures high quality extruded aluminium products.

Dulun currently supplies the local market as well as exporting to various overseas countries and now wishes to expand their sales into Australia.

Dulun has exported aluminium products to a customer in Australia in 2012 but the client has been required to pay CVD and DD at the highest rate as Dulun has not yet been reviewed by the International Trade Remedies.

Dulun has not previously exported to Australia prior to this supply.

We believe that the products exported by Dulun are subject to the current Anti-Dumping Notice No 2012/18 Dumping Commodity Register Rev 21 and as an exporter without previous sales to Australia wishes to apply for an accelerated review of Anti-Dumping Measures and Countervailing Duty regarding aluminium extrusions from China under the provisions of the Australian Customs Act Section 269 ZF.

The products involved are hollow extruded aluminium alloy slats in lengths up to 7.5 meters with width of 77mm and thickness of 1.2 mm. They are used as components for further manufacturing, cutting and powder coating for use mainly in production of commercial doors and shutters.
