I act for Consorzio Casalasco Del Pomodoro "CCDP", Strada Provinciale, 32, 26036 -Rivarolo Del Re – Cremona, Italy (refer to attached documentation for verification). CCDP is seeking an accelerated review of the dumping duty notice recently imposed on Italian imported tomatoes.

Description of the goods affected by this notice as follows:

"Tomatoes, whether peeled or unpeeled, prepared or preserved otherwise than by vinegar or acetic acid, either whole or in pieces (including diced, chopped or crushed) with or without other ingredients (including vegetables, herbs or spices) in packs not exceeding 1.14lts in volume.

The goods excluded from this definition are **pastes, purees, sauces, pasta sauces, juice** or sun dried tomatoes"

CCDP wishes to make the application for an accelerated review on the basis that :

1) During the period July 1 2012 to June 30 2013 the only tomato products that **CCDP** imported to Australia were as below and such fall outside the terms of reference of the dumping notice:

Tomato Polpa – 10kg Bag in Box Fine Chopped Tomato - 10 kg Bag in Box Strained Tomato Passata/Sauce – 700g bottle

Specifications for these products are attached for your perusal. Volumes exported of these products to Australia during this period are also attached (this sales information is classified as commercially sensitive and not for public release).

Furthermore CCDP attests that there was no sister company or related entity to CCDP exporting Tomato products to Australia during this period - please refer to the attached declaration.

2) The application of the "all other rate" (duty) is considered incorrect given the fact that CCDP was never actually assessed

3) CCDP now wishes to export other tomato products to Australia ad considers itself as a new exporter of these products.

4) Normal Value Pricing details of the products to be imported are contained within the Table attached. **This information is highly confidential – please treat it accordingly.**
