ANTI-DUMPING NOTICE NO. 2013/101

Zinc coated (galvanised) steel and Aluminium zinc coated steel Exported from the People's Republic of China by South Polar Lights Steel (Shanghai) Co., Ltd

Termination of Accelerated Reviews

Customs Act 1901 – Part XVB

On 23 October 2013, Anti-Dumping Notice (ADN) 2013/81 was published, providing notification that the Commissioner of the Anti-Dumping Commission (the Commission) had commenced accelerated reviews (one for each product) of the dumping duty and countervailing duty notices in respect of zinc coated (galvanised) steel and aluminium zinc coated steel exported to Australia from the People's Republic of China (China) in so far as they relate to South Polar Lights Steel (Shanghai) Co., Ltd (SPLCO).

As the application for the accelerated reviews was not rejected by the Commissioner, the lodgement date of 29 September 2013 was the commencement date of the accelerated reviews.

Effect of the accelerated reviews

As the Commissioner did not reject the application, and continued the accelerated reviews, a declaration under paragraph 269ZH(b) of the *Customs Act 1901* (the Act) was made to ensure securities in respect of interim dumping duty and interim countervailing duty that were payable on exports of galvanised steel and aluminium zinc coated steel were collected for the period of the review.

Termination grounds

SPLCO was sent an exporter questionnaire to complete by 21 November 2013. Although a response to the exporter questionnaire was received by the due date, the Commission assessed SPLCO's response and found that insufficient information was provided.

The Commission considers that the failure to provide a substantially compliant response to the questionnaire amounts to a refusal to co-operate with an aspect of each accelerated review. Therefore, in accordance with subsection 269ZE(3) of the Act, the Commissioner has decided to terminate both accelerated reviews.

Effect of the termination of the accelerated reviews

Termination of this accelerated reviews means that securities taken on galvanised steel or aluminium zinc coated steel exported by SPLCO and entered for home consumption in the period 23 October 2013 to 20 December 2013 will now be converted to interim dumping duty and interim countervailing duty.

The effective rates of duty are at the 'all other exporters' rate specified in the dumping duty and countervailing duty notices published by the Commission on 5 August 2013. These rates can be found at: <u>http://www.adcommission.gov.au/system/CurrentMeasures.asp.</u>

Future exports of galvanised steel and aluminium zinc coated steel by SPLCO will also be subject to this level of measures.
