**Anti-circumvention Inquiry 447 into certain aluminium extrusions exported to Australia through one or more third countries from the People's Republic of China**

We refer to your letter of 24 October 2017 and Anti-Dumping Notice No. 2017/137 (**Notice**).

We are instructed, in respect of the Inquiry, that:

- 1 Our client imports goods into Australia from its Thai supplier, [REDACTED] [THAI SUPPLIER].
- 2 To our client's knowledge the goods our client imports from [REDACTED] [THAI SUPPLIER] are manufactured in Thailand by [REDACTED] [THAI SUPPLIER] and exported only from Thailand.
- 3 Our client is confident that the goods it imports from [REDACTED] [THAI SUPPLIER] are only sourced from Thailand. Our client is in possession of Certificates of Origin to this effect, which are **enclosed** [REFER TO THE CONFIDENTIAL ENCLOSURE].
- 4 Our client has been importing the goods from [REDACTED] [THAI SUPPLIER] for approximately 18 years without any issue or suggestion that the goods are sourced from any supplier other than [REDACTED] [THAI SUPPLIER] or country other than Thailand.
- 5 [REDACTED] [THAI SUPPLIER] has informed our client that it sources some ingot and billet from the world market however all production takes place in Thailand. In some cases [REDACTED] [THAI SUPPLIER] does purchase extrusions from China however these are limited to profiles which are too large for [REDACTED] [THAI SUPPLIER] to extrude and are only sold in the domestic Thai market. All extrusions purchased by our client from Thailand are produced by [REDACTED] [THAI SUPPLIER] in Thailand.

As such, we are instructed that our client does not consider the goods imported by it from Thailand to fall within the ambit of the Inquiry.
