Dear Sirs,

reference is made to the Exporter Questionnaire sent to La Doria S.p.A. and relating to the dumping application by SPC Ardmona.

As known, the document is divided into two parts:

- Part 1 (relating to preliminary information about our company), to be sent within 26<sup>th</sup> July 2013; and
- Part 2 (relating to specific information), to be sent within 19<sup>th</sup> August, 2013.

As to Part 1, please find attached our replies and consider us at your disposal for any further clarification you may have. This part does not contain confidential information, therefore it is marked "For public record" (instead of "For official use only").

As to Part 2, we would kindly ask you an extension of time because the deadline of 19<sup>th</sup> August 2013 is extremely burdensome for us. Please note that our request is based on the following circumstances:

- 1) July and August are the only two months dedicated to the **tomato crop**; this means that the company is in the peak production period.
- 2) Employees not involved in tomato crop are **on vacation** because in Italy it is summertime : furthermore, Thursday 15<sup>th</sup> August is **public holiday** (this means that until Sunday 18<sup>th</sup> August we will have a long week-end).
- 3) La Doria is a listed entity and, pursuant to Italian Law (i.e. Legislative Decree no. 58/98), it shall file an **Interim Financial Statement** (the so-called "*Relazione Semestrale*"). As you may verify on the Italian Stock Exchange website (<http://www.borsaitaliana.it/borsa/azioni/elenco-completo-eventi.html?isin=IT0001055521&lang=it>), the approval of La Doria Interim Financial Statement is scheduled on 29<sup>th</sup> August 2013. This means that staff not involved in the tomato crop or on vacation, is filing the above-mentioned document.

In light of the above - and considering the complexity of the documentation requested - we hope you may extend the deadline and let us reply to Part 2 within 19<sup>th</sup> September 2013 (or the different date you deem adequate).
