



## **ANTI-DUMPING NOTICE NO. 2016/122**

### **Extensions of Time Granted to Issue the Statement of Essential Facts and Final Reports For Nine Reviews of Anti-Dumping Measures Relating to Zinc Coated (Galvanised) Steel and Aluminium Zinc Coated Steel Exported from the People's Republic of China and Taiwan**

*Customs Act 1901 – Part XVB*

On 30 August 2016 and 22 September 2016, I, Dale Seymour, the Commissioner of the Anti-Dumping Commission published notices announcing the initiation of six reviews of the anti-dumping measures applying to zinc coated (galvanised) steel and three reviews of the anti-dumping measures applying to aluminium zinc coated steel exported to Australia from the People's Republic of China (China) and Taiwan by certain exporters.

Further details of the initiation of these reviews and a full description of the relevant goods is available in Anti-Dumping Notice (ADN) Nos. 2016/86, 2016/87, 2016/101 and 2016/102. The SEFs will set out the facts on which I propose to base recommendations to the Assistant Minister for Industry, Innovation and Science and the Parliamentary Secretary to the Minister for Industry, Innovation and Science (the Parliamentary Secretary) in relation

to these reviews.<sup>1</sup>

The final reports will set out my recommendations to the Parliamentary Secretary in relation to whether the relevant dumping duty notices remain unaltered or have effect in relation to the applicants (set out in the table above) as if different variable factors had been ascertained.

I requested extensions of time under subsection 269ZHI(1) of the *Customs Act 1901* (the Act) for the publication of the SEFs and to provide the final reports to the Parliamentary Secretary. I requested these extensions to align the due dates for all of the reviews with each other and with an ongoing investigation into galvanised steel from the Republic of India (India), Malaysia, and the Socialist Republic of Vietnam (Vietnam), which was initiated on 7 October 2016 (ADN 2016/105 refers). The alignment of the due dates will also allow for greater administrative efficiencies and consistency of findings in regards to the nine reviews.

The Parliamentary Secretary has, under subsection 269ZHI(3) of the Act, extended the deadline for the publication of the SEFs and submission of the final reports. The SEFs for all nine reviews will now be placed on the public record no later than **25 January 2017**.<sup>2</sup> For all nine reviews, a recommendation to the Parliamentary Secretary will now be made in a final report due on or before **13 March 2017**.<sup>3</sup>
