Dear sirs,

On 10 July 2013 the Anti-Dumping Commission (the Commission) initiated an investigation into the alleged dumping of prepared or preserved tomato products exported to Australia from Italy (the goods). Please refer to ADN 2013/59 (attached) for the full details of the investigation and goods description.

This investigation follows an application by SPC Ardmona Operations Limited, a member of the Australian industry manufacturing like goods, for the publication of a dumping notice.

Your company has been identified either in the Commission's records, in the application, or by an identified importer, as a possible manufacturer or exporter of the goods from Italy during the investigation period of 1 July 2012 to 30 June 2013.

Accordingly, you are invited to participate in the Commission's investigation by completing the exporter questionnaire and the associated spreadsheets. This exporter questionnaire comprises two separate parts:

- **Part 1** – Preliminary information about your company (**due by 26 July 2013**), and
- **Part 2** – Specific information about your company's sales/costs relating to export and domestic prepared or preserved tomatoes. (**due by 19 August 2013**)

Please note that you are not required to complete the attached questionnaire. However, if you do not provide all of the information sought, or if you do not allow the Commission to verify the information, we may deem that you did not cooperate with the investigation. In that case we may assess a dumping margin for your company based upon normal values that may be the highest determined in your country during the investigation period.

Therefore, it is considered to be in your interests to provide a complete exporter questionnaire response.
