## **ANTI-DUMPING NOTICE NO. 2017/148**

## Steel rod in coils

**Exported from the People's Republic of China** 

Extension of time granted to issue the Statement of Essential Facts and the Final Report

in relation to two reviews of anti-dumping measures relating to Jiangsu Shagang Group Co., Ltd (No. 413) and Hunan Valin Xiangtan Iron & Steel Co., Ltd. (No. 414)

Customs Act 1901 - Part XVB

On 24 May 2017, the Commissioner of the Anti-Dumping Commission (the Commissioner) published a notice announcing the initiation of two separate reviews of anti-dumping measures, in the form of a dumping duty notice, in respect of steel rod in coils (the goods) exported to Australia from the People's Republic of China (China) as they affect Jiangsu Shagang Group Co., Ltd. (Shagang) and Hunan Valin Xiangtan Iron & Steel Co., Ltd. (Valin), both of whom are exporters of the goods (Reviews 413and 414).

A full description of the goods is available in that notice, Anti-Dumping Notice (ADN) No. 2017/76 (initiation notice). The initiation notice is available on the Anti-Dumping Commission's (Commission) website at <a href="https://www.adcommission.gov.au">www.adcommission.gov.au</a>.

The initiation notice advised that the statement of essential facts (SEF) would be placed on the public record on or before 11 September 2017. The initiation notice also advised that a recommendation to the Assistant Minister for Industry, Innovation and Science and Parliamentary Secretary to the Minister for Industry, Innovation and Science (the Parliamentary Secretary)<sup>1</sup> in relation to each review would be made in a final report on or before 26 October 2017.

On 30 August 2017, the Commissioner then published a notice that an extension of time had been granted for the publishing of a SEF and the final report to the Parliamentary Secretary for Reviews 413 and 414, making the new date for publishing the SEF on 17 October 2017.

This initial extension of time was granted to ensure the case team had adequate time to consider verified billet costs of the cooperating exporters in Investigations 416 and 418 as replacement costs for Reviews 413 and 414, which only became available after the SEF was originally due. See Anti-Dumping Notice (ADN) No. 2017/123 for more details on the first extension of time granted.

As discussed in ADN No. 2017/123, the Commission intended to use verified raw material costs from exporters in Investigations 416 and 418 as replacement costs for those exporters pertaining to Reviews 413 and 414. In constructing a weighted average replacement cost, however, the case team has experienced a high level of complexity in extracting the actual verified raw material costs at the billet level from the cooperating exporters from Investigations 416 and 418, and has requested an extension of time to finalise a competitive market cost replacement.

Due to the unforeseen complexity arising from the use of verified billet costs, I, Paul Sexton, General Manager, Anti-Dumping Commission, requested an extension of the deadline for the Commissioner to publish the SEF and provide his final report and recommendations to the Parliamentary Secretary.<sup>2</sup> The Commissioner has, under subsection 269ZHI(3) of the *Customs Act 1901*,<sup>3</sup> extended the deadline to publish the SEF, and provide his final report and recommendation.

The SEF will now be placed on the public record on or before **27 October 2017**. Interested parties are invited to make submissions to the Commissioner in response to the SEF within 20 days of the SEF being placed on the public record. A recommendation to the Parliamentary Secretary will now be made in a report due on or before **11 December 2017**.
