ANTI-DUMPING NOTICE NO. 2016/98

Customs Act 1901 - Part XVB

Certain Hot Rolled Structural Steel Sections

Exported from Japan, the Republic of Korea, Taiwan and the

Kingdom of Thailand

Findings in Relation to a Review of Anti-Dumping Measures

Notice under subsection 269ZDB(1)(a)(iii) of the Customs Act 1901 and subsection 8(5) of the Customs Tariff (Anti-Dumping) Act 1975

The Commissioner of the Anti-Dumping Commission has completed a review, which was initiated on 18 April 2016, of the anti-dumping measures applying to certain hot rolled structural steel sections (the goods) exported to Australia from Taiwan and the Kingdom of Thailand (Thailand). The review was limited to examining whether the variable factors relevant to the taking of the anti-dumping measures as they affect Tung Ho Steel Enterprise Corporation (Tung Ho Steel) (Taiwan) and Siam Yamato Steel Co., Ltd. (SYS) (Thailand) should be varied.

Recommendations resulting from that review, reasons for the recommendations and material findings of fact and law in relation to the review are contained in Anti-Dumping Commission Report No. 345 and Commission Report No. 346 (REP 345 and REP 346).

I, CRAIG LAUNDY, Assistant Minister for Industry, Innovation and Science and Parliamentary Secretary to the Minister for Industry, Innovation and Science (the Parliamentary Secretary),¹ have considered REP 345 and REP 346 and have decided to accept the recommendations and reasons for the recommendations, including all the material findings of facts or law set out in REP 345 and REP 346.

Under subsection 269ZDB(1)(a)(iii) of the *Customs Act 1901* (the Act), I declare that, for the purposes of the Act and the *Customs Tariff (Anti-Dumping) Act 1975* (Dumping Duty Act), that, with effect from the date of publication of this notice, the dumping duty notice currently applying to the goods exported to Australia from Taiwan by Tung Ho Steel and from Thailand by SYS is to be taken to have effect or to have had effect as if I had fixed different variable factors in respect of Tung Ho Steel and SYS, relevant to the determination of duty.

¹ The Minister for Industry, Innovation and Science has delegated responsibility with respect to anti-dumping matters to the Parliamentary Secretary and accordingly the Parliamentary Secretary is the relevant decision maker. On 19 July 2016, the Prime Minister appointed the Parliamentary Secretary to the Minister for Industry, Innovation and Science as the Assistant Minister for Industry, Innovation and Science.

To preserve confidentiality, details of the revised variable factors such as the Ascertained Export Price (AEP), Ascertained Normal Value (ANV) and Non-Injurious Price (NIP) will not be published.

I, CRAIG LAUNDY, the Parliamentary Secretary, <u>DETERMINE</u>, pursuant to section 8(5) of the Dumping Duty Act, that the interim dumping duty payable on HRS exported to Australia by Tung Ho Steel and SYS be an amount worked out in accordance with the floor price duty method pursuant to subsections 5(4) and (5) of the *Customs Tariff* (*Anti-Dumping*) Regulation 2013 with effect from the date of this notice.

The floor price set for these exporters is confidential. Interested parties may seek a review of this decision by lodging an application with the Anti-Dumping Review Panel (www.adreviewpanel.gov.au) in accordance with the requirements in Division 9 of Part XVB of the Act, within 30 days of the publication of this notice.
