## Findings in Relation to a Revocation Review of Anti-Dumping Measures

Notice under subsection 269ZDB(1) of the Customs Act 1901

The Commissioner of the Anti-Dumping Commission has completed the review, which commenced on 6 November 2015, of the anti-dumping measures applying to polyvinyl chloride homopolymer resin ('the goods") exported to Australia from Japan, the Republic of Korea and the United States of America.

Recommendations resulting from that review, reasons for the recommendations and material findings of fact and law in relation to the review are contained in *Anti-Dumping Commission Report No. 317* (REP 317).

I, KAREN LESLEY ANDREWS, the Assistant Minister for Science and Parliamentary Secretary to the Minister for Industry, Innovation and Science have considered REP 317 and have decided to accept the recommendations and reasons for the recommendations, including all the material findings of fact or law set out in REP 317.

Under subsection 269ZDB(1)(a)(ii) of the *Customs Act 1901* (the Act), I declare, for the purposes of the Act and the *Customs Tariff (Anti-Dumping) Act 1975*, that to the extent that the anti-dumping measures concerning the goods involved the publication of dumping duty notices that, with effect from 1 January 2016, the notices are taken to have been revoked in relation to exporters generally.

Interested parties may seek a review of this decision by lodging an application with the Anti-Dumping Review Panel (<a href="www.adreviewpanel.gov.au">www.adreviewpanel.gov.au</a>) in accordance with the requirements in Division 9 of Part XVB of the Act, within 30 days of the publication of this notice.
