Investigation into Alleged Dumping

Summary:

The Anti-Dumping Commission (the Commission) has received formal submissions from a number of interested parties identified as exporters of prepared or preserved tomato products exported to Australia from Italy (the Goods) requesting an extension of time, of varying durations beyond the deadline of 19 August 2013, with respect to the submission of completed exporter questionnaire responses.

Given the relatively high number of entities who have submitted such requests, the Commission has collated the documentary evidence relating to requests that have been received from exporters who have:

- a) Provided an individual formal request for an extension; and
- b) Who have submitted a completed response to Part 1 of the questionnaire prior to, or in conjunction with, their extension request.
