**ANTI-DUMPING NOTICE NO. 2017/49**

*Customs Act 1901 – Part XVB*

**Steel reinforcing bar**

**Exported to Australia from the People’s Republic of China  
Findings in Relation to a Review of Anti-Dumping Measures  
relating to Jiangsu Shagang Group Co., Ltd. (No. 411)  
Hunan Valin Xiangtan Iron & Steel Co., Ltd. (No. 412)  
and Jiangsu Yonggang Group Co., Ltd (No. 423)**

***Notice under subsection 269ZDB(1)(a)(iii) of the Customs Act 1901***

The Commissioner of the Anti-Dumping Commission has completed three reviews, which were initiated on 19 May 2017 (reviews 411 and 412) and 29 June 2017 (Review 423), of the anti-dumping measures applying to steel reinforcing bar ('the goods') exported to Australia from the People’s Republic of China (China) by Jiangsu Shagang Group Co., Ltd., Hunan Valin Xiangtan Iron & Steel Co., Ltd. and Jiangsu Yonggang Group Co., Ltd. The reviews examined whether the variable factors relevant to the taking of the anti-dumping measures as they affect the aforementioned exporters of the goods from China should be varied.

*Anti-Dumping Commission Report Nos. 411, 412, and 423* (REP 411, 412 and 423) contains the recommendations resulting from the reviews, reasons for the recommendations and material findings of fact and law.

I, ZED SESELJA, Assistant Minister for Science, Jobs and Innovation, have considered REP 411, 412 and 423 and have decided to accept the recommendations and reasons for the recommendations, including all the material findings of facts and law.

Under subsection 269ZDB(1)(a)(iii) of the *Customs Act 1901* (the Act), I DECLARE that, for the purposes of the Act and the *Customs Tariff (Anti-Dumping) Act 1975* (Dumping Duty Act), that, with effect from the day following publication of this notice, the dumping duty notice currently applying to the goods exported to Australia from China be taken to have effect as if I had fixed different variable factors in respect the exporters subject to these reviews as detailed in the table below, relevant to the determination of duty.

Exporter	Dumping margin	Fixed rate of IDD	Duty method
Hunan Valin Xiangtan Iron & Steel Co., Ltd	19.7%	19.7%	Combination of fixed and variable duty method, consisting of a fixed rate of IDD plus a variable component of IDD equal to the amount, if any, by which the actual export price is lower than the ascertained export price.
Jiangsu Shagang Group Co., Ltd	12.3%	12.3%	
Jiangsu Yonggang Group Co., Ltd	6.1%	6.1%	

To preserve confidentiality, details of the revised variable factors being the Ascertained Export Price (AEP) and Ascertained Normal Value (ANV) will not be published.
