Investigation into Rod In Coil exported from Indonesia, Taiwan and Turkey – Exporter **Questionnaire Redactions**

OneSteel Manufacturing Pty Ltd (OneSteel") has been monitoring the exporter questionnaire responses released for the public file in the current Rod In Coil ("RIC") investigation (investigation No. 240. It is noted that the exporter questionnaire responses placed on the public file to date have certain amounts of information redacted, on the grounds that the information that has been removed is commercially sensitive.

OneSteel would like to highlight with the Anti-Dumping Commission that certain redacted information is not commercially sensitive and can be accessed via the manufacturer's website or via suppliers within Australia.

In particular, information relating to like goods that compete with goods the subject of the application are considered to be non-confidential. The Commission has detailed to interested parties that for information considered to be sensitive, a non-confidential summary of the redacted information is required. It is apparent from the public file versions of the completed exporter questionnaire responses, this principle is not being adhered to.

OneSteel highlights the following concerns with the exporter questionnaires received to date:

(i) PT Gunung Raja Paski

Has completed Sections A-1, A-2, A-3 and A-4 (Parts 1-5). All remaining sections of the exporter questionnaire are blank, with no attempt to provide a non-confidential summary.

It is OneSteel's view that information relating to the exported goods (i.e. grades, grade name, specifications) at Section C, and items that may be the subject of adjustments (Section E - Fair Comparison) require non-confidential details. This information is all available on PT Gunung Raja Paski's website (see wire rod brochure).

(ii) DILER Dis Ticaret Anonim Sirketi

Has completed the Exporter Questionnaire Response and provided non-confidential summaries. Section C does not detail the goods exported to Australia (grades, grade name, specifications), however, this is a comment at Section C-3 that the exported goods are identical to the goods sold domestically (hence no specification adjustments necessary). This point can only be established if t the exporter published specification information concerning the goods exported to Australia.

(iii) PT Ispat Indo

No details concerning the exported goods and like goods. The redaction of information concerning the goods exported to Australia cannot be justified on grounds of commercial sensitivity. RIC is a commodity product and all grades produced by PT lspat Indo are detailed on its website.

The Commission is requested to seek full disclosure of the goods and like goods by PT Ispat Indo.

(iv) Quintain Steel Co., Ltd

The exporter has not disclosed the like goods or goods exported to Australia. This information is available on the Quintain Steel Co., Ltd website, including grades and specifications. This information is not commercially sensitive.

(v) Habas Sinai ve Tibbi Gazlar Istihsal Endustrisi A.S.

The exporter has not disclosed the like goods grades and/or specifications, nor for the goods exported to Australia. This information does not appear on the company's website, however, it is not information that can be claimed as commercially sensitive.

The Commission is requested to seek disclosure of the like goods and goods exported to Australia (grades, grade names, specifications) by the exporter.

It is evident from the above that the above-nominated public file versions of the exporter questionnaire responses do not adequately disclose information that is generally available in the public domain. It is requested that the Commission seek the relevant exporter's assistance to adequately disclose non-confidential information in the exporter questionnaire responses.
