As discussed during the verification, we understand that Capral has made certain allegations regarding “common management between exporter and importer”. In response, we wish to confirm, with respect to Shun E Kuang (“SEK”) and Darley and its affiliated companies in Australia (“Darley”):

- SEK is a non-beneficial shareholder of Darley Aluminium Trading Pty Ltd.
- SEK does not hold a beneficial interest in any shares in Darley.
- SEK has no directorship in Darley.
- SEK does not participate in the management of Darley.

To be clear, there is no form of “common management” between Darley and Zhongya which might have affected the export prices between Zhongya and Darley in relation to the goods under consideration, as alleged by Capral.
