SECTION A: BACKGROUND AND GENERAL INSTRUCTIONS

BACKGROUND

On 15 September 2014, the Anti-Dumping Commission (the Commission) commenced a review of anti-dumping measures (in the form of a dumping duty notice and a countervailing duty notice) applying to aluminium road wheels (ARWs) exported to Australia from China.

The review is the result of an application by Jiangsu Yaozhong Aluminium Wheels Co., Ltd (Jiangsu Yaozhong) seeking a review of the anti-dumping measures as they apply to its exports to Australia. The Parliamentary Secretary to the Minister for Industry and Science, who is responsible for anti-dumping matters, has accepted a recommendation from the Commissioner of the Anti-Dumping Commission to extend the review to all exporters covered by the measures.

The review will be limited to examining whether the variable factors relevant to the taking of the anti-dumping measures, as they affect exporters of ARWs to Australia from China, should be varied.

Following initiation of this review, the Commission submitted a Government Questionnaire to the Government of China (GOC) which sought information that would assist the Commission undertaking the countervailing and market situation considerations as part of this review.

The GOC provided a response to the Government Questionnaire, which is accessible.

PRODUCT CONCERNED

Description

The goods the subject of the anti-dumping measures are:

aluminium road wheels for passenger motor vehicles, including wheels used for caravans and trailers, in diameters ranging from 13 inches to 22 inches.

For clarification, the goods include finished or semi-finished ARWs whether unpainted, painted, chrome plated, forged or with tyres and exclude aluminium wheels for go-carts and All-Terrain Vehicles.

Tariff classification

The goods are currently classified to the tariff subheadings 8708.70.91 (statistical code 78), 8708.70.99 (statistical code 80) and 8716.90.00 (statistical code 39) in Schedule 3 of the *Customs Tariff Act 1995*.

These goods are subject to 4 per cent customs duty.

REVIEW PERIOD

The decision on whether any or all of the relevant variable factors (export price, normal value, non-injurious price and the amount of countervailable subsidy) have changed will be determined on the basis of a review period from 1 July 2013 to 30 June 2014 (hereinafter referred to as 'the review period').

PURPOSE OF THIS QUESTIONNAIRE

Information has been provided to the Commission regarding the possible existence and receipt of new countervailable subsidy programs not included in the 56 programs which were assessed in the previous investigation into ARWs.

The Commission considers that further investigation of these new programs is warranted, in order to determine whether they are countervailable.

The Commission is submitting this supplementary questionnaire to request necessary information from the GOC that will assist in determining whether these additional programs are countervailable.

RESPONSE TO THIS QUESTIONNAIRE

The GOC does not have to complete this questionnaire.

However, if the GOC does not respond the Commission may be required to rely on information supplied by other parties in making its determinations in relation to the new programs.

Therefore, it is considered to be in the GOC's interests, and the interest of Chinese exporters of the goods, to provide a complete response.

If the GOC chooses to respond to this questionnaire, the response is due by **COB 5 June 2015**.


