## Re: Quenched & Tempered Steel Plate exported from Sweden, Japan and Finland – SSAB 2013 Financial Results

Bisalloy Steel Group Pty Ltd ("Bisalloy") has obtained a copy of the 2013 financial statements for SSAB Swedish Steel Pty Ltd ("SSAB Swedish Steels") as lodged with the Australian Securities & Investments Commission ("ASIC") — Confidential copy attached. SSAB Swedish Steels is the Australian importer and supplier of Quenched and Tempered ("Q&T") steel plate exported from Sweden.

Bisalloy draws to the attention of the Anti-Dumping Commission ("the Commission") the following relevant information contained in the SSAB Swedish Steel return:

- SSAB Swedish Steel's costs of sales were \$40.6M, of which \$37.0M was purchased from SSAB Singapore;
- SSAB Swedish Steel has current sales (including cash) of \$15.2M. Included in trade creditors is an amount of \$18.4M owing to SSAB Singapore;
- For the 2013 year, SSAB Swedish Steels has paid approximately 50 per cent of the cost of materials sourced from SSAB Singapore;
- SSAB Swedish Steels is reliant on a letter of financial support from its holding company, SSAB EMEA AB.

The SSAB Swedish Steel financial statements also acknowledge that during the 2013 year (that coincides with the investigation period in Investigation No. 234), the following is observable:

- SSAB Swedish Steel incurred a gross loss of \$500k there is an acknowledgment of sales below costs, and that this blows out by an additional \$3.5M in administration, marketing and other expenses);
- SSAB Swedish Steel has negative current assets of \$3M; and
- In the absence of support from its parent company, SSAB Swedish Steel's combined working capital and negative equity suggests it would not be able to operate as a going concern.

The above matters are relevant to Bisalloy's claims that Q&T steel plate exported to Australia from Sweden during 2013:

- were at dumped prices;
- · did not recover the fully absorbed CTM&S;
- were at FOB export prices that were not reflected in subsequent selling prices in Australia and, because of the relationship between the exporter and the importer, the export prices were affected by the relationship.



In considering the publication of a Preliminary Affirmative Determination ("PAD") Bisalloy requests the Commission to take full account of the recent information contained in SSAB Swedish Steel's 2013 return. It is Bisalloy's view that the information contained in the ASIC return confirms Bisalloy's assertions concerning related party sales as detailed in the application.
