PART B - Imports and forward orders

1. The goods under investigation

The goods under consideration are single and multi-core cables insulated with polymeric materials intended for use in electric installations at working voltages up to and including 1 kV with the following characteristics:

- · suitable for connection to mains power supply; and
- comply with Australian Standards AS/NZS 5000.1 or AS/NZS 5000.2.

The goods under consideration fall into the following categories:

- flat cables, insulated and sheathed, with two cores and earth and with conductor area up to three square millimetres;
- building wire, insulated, unsheathed, single core and with conductor area from two to three square millimeters; and
- single core double insulated cable, insulated and sheathed and with conductor area from 12 to 60 square millimetres.

The goods are classified to the tariff subheading 8544.49.20 (statistical codes 40 and 41) of Schedule 3 to the Customs Tariff Act 1995. The general rate of duty is currently 5%. Imports from China are subject to the Developing Country Status duty rate of 4%.

Electra has received the list of imports for electric cables in the period of 1 July 2010 to 30 June 2011. All the shipments were imported by Electra and relate to goods under consideration. It is considered that almost all of the import entries are correct, although some errors in quantity and value have been discovered.

Please complete the "Part B – cost to import and sell" spreadsheet with details for each <u>selected</u> shipment. Customs and Border Protection will advise you which shipments have been selected for this more detailed examination. (Please note that you cannot complete this part of the questionnaire until Customs and Border Protection provides you with the respective listing of your imports.).

See attached spreadsheet entitled *Electra IO B2 - Selected shipments*. Electra would like to mention the following about this spreadsheet:

- The shipment In each case has been considered to be all of the goods in the shipment. In all cases the goods under consideration were only some of the goods in the shipment concerned.
- The SG&A percentage is derived directly from Electra's financial accounts and has not been adjusted downwards to account for any differences pertaining to the goods under consideration.
- The exchange gain percentage only relates to trading and has also been derived directly from Electra's accounts.
- The average selling price is not available on a per shipment basis. Instead Electra has used the average per unit selling price for all sales in the month after the month of shipment. The model mix involved in the comparison between shipment cost and selling price is not the same.
- The average selling price is unrebated, in that the models in any particular shipment would be sold to different customers and therefore different rebate levels could be expected.
- Because of the different cost and sales basis, Electra has not completed the "Profit per KM" and "Profitability (%)" rows.

The multiple models, GUC/non-GUC mix, the [CONFIDENTIAL TEXT DELETED - number of invoices] invoices and about [CONFIDENTIAL TEXT DELETED - number of lines in invoices] lines in those invoices, combined with the different assumptions as to costs for certain models, customer rebates, and cable lengths make it difficult to absolutely and precisely isolate prices and costs. Electra enjoyed strong profitability in the POI and looks forward to further demonstrating its financial data and having it verified as Customs may request.

Electra has provided details of all its sales of electric cables in the Australian market for the period 1 July 2010 to 30 June 2011. This is a download from Electra's sales data into .xls spreadsheets on a month by month basis (12 spreadsheets).

Electra has a large number of invoices. For example, in the month of July 2010 the total number of invoices raised was [CONFIDENTIAL TEXT DELETED – number of invoices]. Additionally any one invoice can include many different model units.

The downloaded sales history data has been organised quickly in the most practically feasible way. Most items of information as listed above are included, with the following exceptions:

- Country of origin this information is not shown in the downloaded invoice listing level. All goods originate in and are imported from China.
- Delivery terms this information is not shown in the downloaded invoice listing level. All sales are FIS (free into customer store), except for a small number of sales that are collected by the customers ex-warehouse.
- Credit terms this information is not shown in the downloaded invoice listing level. Credit terms range from [CONFIDENTIAL TEXT DELETED - credit arrangements with customers].
- 7. Model or grade this information is not shown in the downloaded invoice listing level. Each invoice contains one to multiple models (product types).
