



ANTI-DUMPING NOTICE NO. 2014/12

Zinc coated (galvanised) steel and Aluminum zinc coated steel

Exported from the People's Republic of China

Variation of decision to impose measures

Customs Act 1901 – Part XVB

The Anti-Dumping Review Panel (ADRP) has completed its review of certain findings made in the Commission Report No. 193 (REP 193) in respect of zinc coated (galvanised) steel and aluminium zinc coated steel exported to Australia from the People's Republic of China (China).

The application for review was made by the Government of China and relates only to exports from China. A copy of the application and the ADRP Report is available on the ADRP website at www.adreviewpanel.gov.au

Parliamentary Secretary's Decision

The Parliamentary Secretary to the Minister for Industry has considered and accepted the recommendation to affirm the decisions to publish dumping duty notices for both galvanised steel and aluminium zinc coated steel, including all material findings of fact or law relating to that recommendation as set out in the ADRP Report.

The Parliamentary Secretary has also considered and accepted the findings of the ADRP Report, including all material findings of fact and law, in relation to the grounds for review of the decision to publish the countervailing duty notices. However, the Parliamentary Secretary did not accept the ADRP's recommendation to revoke the countervailing duty notices but decided to vary the countervailing duty notices so as to reduce the countervailable subsidies by the amounts referable to programs 1 to 3 described in REP 193.

To give effect to this decision the Parliamentary Secretary has published a notice under section 269ZZM of the *Customs Act 1901* (the Act). This notice varies the countervailing duty notices¹ published in respect of galvanised steel and aluminium zinc coated steel exported to Australia from China, which were published on 5 August 2013 in *The Australian* and the *Gazette*.

Notice of the Parliamentary Secretary's decision was published in *The Australian* on 20 February 2014. The notice has effect from 5 August 2013.

Effective Rates of Duty

The Parliamentary Secretary's decision to vary the countervailing duty notices requires an amendment to the interim dumping duty payable on imports of galvanised steel and aluminium zinc coated steel. This is because the original dumping margins were reduced by the amount of subsidy attributable to subsidy programs 1 to 3 in determining the interim dumping duty payable.

The effective rates of duty as a result of the Parliamentary Secretary's decision are set out in the tables below.

The actual duty liability may be higher than the effective rate of duty due to a number of factors. Refund Provisions

Parties that consider they may be eligible for a refund of interim duties paid on galvanised steel and aluminium zinc coated steel exported to Australia from China as a result of the Parliamentary Secretary's decision may apply for a refund of this interim duty under Division 3 of Part VIII of the Act.

Right of Review

Interested parties may seek a review of this decision by lodging an application with the Federal Court of Australia, in accordance with the requirements in the *Administrative Decisions Judicial Review Act 1975*, within 28 days of the publication of the notice.
