



## **ANTI-DUMPING NOTICE NO. 2013/106**

### **Power transformers**

**Exported from the People's Republic of China, the Republic of Indonesia, the Republic of Korea, Taiwan, Thailand and the Socialist Republic of Vietnam**

### **Revision to level of securities**

#### ***Customs Act 1901 – Part XVB***

On 20 November 2013, the Commissioner of the Anti-Dumping Commission (the Commissioner), in accordance with paragraph 269TD(4)(a) of the *Customs Act 1901* (the Act), gave public notice that a preliminary affirmative determination had been made as there appeared to be sufficient grounds for the publication of a dumping duty notice in respect of power transformers exported to Australia from the People's Republic of China (China), the Republic of Indonesia (Indonesia), the Republic of Korea (Korea), Taiwan and the Socialist Republic of Vietnam (Vietnam).

Further details of this preliminary affirmative determination are available in Anti-Dumping Notice (ADN) No. 2013/92. This ADN is available on the internet at [www.adcommission.gov.au](http://www.adcommission.gov.au).

At the time of making the preliminary affirmative determination, the Commissioner further determined that securities should be required and taken under section 42 of the Act in respect of interim dumping duty that may become payable in respect of the goods from China, Indonesia, Korea, Taiwan and Vietnam, being satisfied that it is necessary to require and take securities in order to prevent material injury occurring to the Australian industry while the investigation continues.

Securities were taken as outlined in ADN No. 2013/92 for any interim dumping duty that may become payable in respect of the goods entered for home consumption on or after 27 November 2013.

On further consideration of the relevant information, the Commissioner has revised the level of securities as required and taken under section 42 of the Act in respect of interim dumping duty that may become payable in relation to exports of the goods to Australia from China and Korea.

The revised securities will be imposed at the rates specified in the below table:

The updated securities will be taken for any interim dumping duty that may become payable in respect of the goods entered for home consumption on or after 18 December 2013.

The security that has been determined is an amount calculated in accordance with the *ad valorem* duty method as outlined in section 5(7) of the *Customs Tariff (Anti-Dumping) Regulations 2013*.

The actual security liability may be higher than the effective rate of security due to a number of factors. The revised securities apply only in respect to the exports of power transformers to Australia from China and Korea. No changes have been made to securities applicable to exports from Indonesia, Taiwan and Vietnam remain as stated in ADN No. 2013/92.

Goods exported to Australia from Thailand continue to be under investigation but are not subject to the preliminary affirmative determination of 20 November 2013.

The Commissioner must report to the Minister for Industry (the Minister) with final recommendations in relation to this investigation on or before 30 April 2014. The Minister will then decide whether to publish a dumping duty notice and, if relevant, the level of measures to be imposed.
