Disagreement of FOCUS MERCHANT MANAGEMENT SDN BHD (FMM) being classified as "Uncooperative and All Other Exporters" by Anti-Dumping Commission (ADC) in regarding ADC Case No 362

Referring to Anti-Dumping Notice No. 2017/37 published on ADC website on 22nd March 2017, FMM has fallen into group of "Uncooperative and All Other Exporters". We are classified into this group because we did not respond to ADC regarding "Exporter Questionnaire (Malaysia)" by the due date of 22nd September 2016. The reason we disagree on the classification of FMM as "Uncooperative and All Other Exporters" is due to ADC do not consider the fact that the Questionnaire wasn't received by FMM and FMM never knew there was a Questionnaire to respond to ADC. We will explain on this matter in this letter.

- (ii) On 27th September 2016, Mr Matthew Williams emailed the URL link of EPR-362 to Sean, refer attachment E, after Sean called and spoke to Matthew regarding not receiving the "Exporter Questionnaire".

- 2.0 FMM did not receive any form of information from ADC to access the ADC website before 22nd September 2016
- 3.0 FMM did not intend to ignore the "Exporter Questionnaire"

1.0 FMM did not receive the letter post of "Exporter Questionnaire"

3.0 FMM did not intend to ignore the "Exporter Questionnaire"

Attachment B shows email correspondence from Sean to **[the importer**] asking on status of ADC investigation. This had proven the concern of FMM on the ADC investigation. FMM could not have ignored the "Exporter Questionnaire" if FMM had received the Questionnaire.
