ANTI-DUMPING NOTICE NO. 2017/98

Certain Zinc Coated (Galvanised) Steel

exported from the Republic of India, Malaysia and the Socialist Republic of Vietnam

Termination of part of an Investigation

Public notice under subsection 269TDA(15) of the Customs Act 1901

I, Dale Seymour, the Commissioner of the Anti-Dumping Commission, on 7 October 2016, initiated an investigation into the alleged dumping of zinc coated (galvanised) steel (the goods) exported to Australia from the Republic of India (India), Malaysia and the Socialist Republic of Vietnam (Vietnam) and alleged subsidisation of the goods exported to Australia from India and Vietnam, following an application lodged by BlueScope Steel Limited (BlueScope) under subsection 269TB(1) of the *Customs Act 1901* (the Act).

A full description of the goods is available in Anti-Dumping Notice (ADN) No. 2016/105. This ADN is available on the Anti-Dumping Commission's (Commission) website¹

As a result of the investigation, I am satisfied that:

- in relation to Hoa Sen Group and Nam Kim Steel Joint Stock Company, there has been no dumping by those exporters of any of the goods during the investigation period and, therefore, I have terminated the dumping investigation in accordance with subsection 269TDA(1)(b)(i) of the Act in so far as it relates to the Hoa Sen Group and Nam Kim Steel Joint Stock Company; and
- in relation to the goods exported from Vietnam, countervailable subsidies have been received in respect of some of the goods, but the subsidies never, at any time during the investigation period, exceeded the negligible level of countervailable subsidy received under subsection 269TDA(16)(b) of the Act and, therefore, I have terminated the subsidy investigation in accordance with subsection 269TDA(2)(b)(ii) of the Act in so far as it relates to all exporters of the goods from Vietnam.

In making these decisions to terminate, I have had regard to the application, submissions from interested parties, Statement of Essential Facts number 370 (SEF 370), submissions in response to the SEF and information obtained during the course of verification visits to the Australian industry producing like goods, exporters, importers and end-users of the goods.
