

Announcing "2006 Export Licensing Management Commodities List" (Ministry of Commerce and General Administration of Customs, Announcement (2005) No. 85

According to the Foreign Trade Law of People's Republic of China and Regulation of the People's Republic of China on the Administration of the Import and Export of Goods, 2006 Export Licensing Management Commodities List and relevant issues are announced as follows:

I. the 46 kinds of export license goods(312 HS code in 8 numbers) will be subject to export quota license, export quota bidding and export license.

(I) Goods subject to export quota: Corn, Rice, Wheat .....Coal, Coke....

(II) Goods subject to export quota bidding:.....Dead-burned magnesia, Light-burned Magnesia .....

(Note: There is nothing relevant to HSS, HRS, coal, coke or iron ore.)

(III) Goods subject to export license: .....Ice fresh beef (Hongkong, Macao, Taiwan markets excluded).....

(Note: There is nothing relevant to HSS, HRS, coal, coke or iron ore.)

II. Regulation regarding global export license management

(Note: There is nothing relevant to HSS, HRS, coal, coke or iron ore.)

III. Corn, rice...coal...are subject to state-owned trade management.

IV. For goods subject to export quota bidding, no matter which kind of trade, all authorized institutes shall sign the export license according to successful winner name list and quantity published by the Ministry of Commerce, and the export license certificate issued by bidding committee.

V. Since June 1<sup>st</sup>, 2005, "other clay" under "clay" item (HS code 2508400000) will not be subject to export quota license.

VI. Since January 1<sup>st</sup>, 2006, export quota license on tea leaf will be canceled.

VII. Regulations regarding Processing Trade:

(I) As goods subject to export quota and processing trade (but those stipulated in provision 2, 3,3,4,5 under this article are excluded), the license issuing institute shall check and sign the export license upon export quota, Processing Trade Approve Certificate and export contract (copy).

(II) Issues regarding Platinum

(III) Issues regarding paraffin and silver

(IV) Issues regarding liquorices and related product

(V) Issues regarding product oil

(VI) Period of validity in term (I) (II) (III) (IV) of this provision will be according to the period

in Processing Trade Export Certificate, if the period in Processing Trade Export Certificate beyond the end of February in the next year, the period of validity will be the end of February. The owner can apply new export license for the next year within valid period. The license issuing institute will issue new certificate in accordance with the export period set forth in Processing Trade Export Certificate.

VIII. Issues regarding small trade on border.

IX. Issues regarding goods subject to One trade one certificate.

X. Issue regarding advertisement sample goods consuming ozone.

XI. The catalogue of textiles subject to export license will be announced separately.

XII. The commodities listed in this catalogue supplied by the GOC under foreign aid projects (monitored chemical products precursor chemicals excluded) will no longer be subject to Quota and Export Licensing Management. This catalogue will enter into force from January 1, 2006; the 2005 Export Licensing Management Commodities List will be abolished at the same time.

# 商务部、海关总署公告 2005年第 85 号 发布《2006 年出口许可证管理货物目录》

[2005]第 85 号

根据《中华人民共和国对外贸易法》和《中华人民共和国货物进出口管理条例》，现发布《2006 年出口许可证管理货物目录》(见附件 1)，并就有关问题公告如下：

一、2006 年实行出口许可证管理的 46 种货物(312 个 8 位 HS 编码)，分别实行出口配额许可证、出口配额招标和出口许可证管理。

(一) 实行出口配额许可证管理的货物是：玉米、大米、小麦、棉花、锯材、活牛(对港澳)、活猪(对港澳)、活鸡(对港澳)、蚕丝类、煤炭、焦炭、原油、成品油、稀土、锑砂、锑(包括锑合金)及锑制品、氧化锑、钨砂、仲钨酸铵及偏钨酸铵、三氧化钨及蓝色氧化钨、钨酸及其盐类、钨粉及其制品、锌矿砂、锡矿砂、锡及锡基合金、白银。

(二) 实行出口配额招标的货物是：蔺草及蔺草制品、碳化硅、氟石块(粉)、滑石块(粉)、轻(重)烧镁、矾土、甘草及甘草制品。

(三) 实行出口许可证管理的货物是：活牛(对港澳以外市场)、活猪(对港澳以外市场)、活鸡(对港澳以外市场)、牛肉、猪肉、鸡肉、消耗臭氧层物质、监控化学品、易制毒化学品、石蜡、铂金(以加工贸易方式出口)、锌及锌基合金、电子计算机、电风扇、自行车、摩托车(含全地形车)及其发动机、车架。其中监控化学品、易制毒化学品在 2006 年将实行两用物项和技术进出口许可证管理，《两用物项和技术进出口许可证管理办**法**》颁布后，按新办法执行。

二、除对港澳出口的活牛、活猪、活鸡实行全球许可证下的国别(地区)配额许可证管理外，其他出口许可证管理货物目录所列出口货物均实行全球出口许可证管理。

三、对玉米、大米、煤炭、原油、成品油、棉花、锑砂、锑(包括锑合金)及锑制品、氧化锑、钨砂、仲钨酸铵及偏钨酸铵、三氧化钨及蓝色氧化钨、钨酸及其盐类、钨粉及其制品、白银实行国营贸易管理。

四、实行出口配额招标的货物，无论何种贸易方式，各授权发证机构均凭商务部下发的中标企业名单及其中标数量和招标办公室出具的《申领配额招标货物出口许可证证明书》签发出口许可证。

五、自 2005 年 6 月 1 日起，矾土项下其他粘土(HS 编码 2508400000)不再实

施出口配额许可证管理；

六、自2006年1月1日起，取消茶叶的出口配额许可证管理；

七、以加工贸易方式出口下列货物，按以下规定办理：

(一)以加工贸易方式出口属出口配额许可证管理的货物[但本条第(二)、(三)、(四)、(五)款规定的除外]，发证机构凭出口配额、《加工贸易业务批准证》及出口合同(正本复印件)核发出口许可证。

(二)进口用于生产铂金的原料加工复出口铂金(铂或白金)，发证机构凭经营企业注册地商务主管部门的《加工贸易业务批准证》、海关加工贸易进口报关单、出口合同(正本复印件)核发出口许可证。

(三)进口原油加工复出口石蜡，进口含白银货物(银粉、未锻造银等及银的半制成品除外)加工复出口白银，以加工贸易方式出口锌及锌基合金，发证机构凭经营企业注册地省级商务主管部门的《加工贸易业务批准证》、海关加工贸易进口报关单、出口合同(正本复印件)核发出口许可证。其中，白银《加工贸易业务批准证》凭商务部批件核发，发证部门加验商务部批件。

(四)以加工贸易方式出口甘草及甘草制品，发证机构凭经营企业注册地省级商务主管部门的《加工贸易业务批准证》、中国医药保健品进出口商会的《申领加工贸易货物出口许可证证明书》、海关加工贸易进口报关单和出口合同(正本复印件)核发出口许可证。

(五)进口原油加工复出口成品油，免领成品油出口许可证。

(六)本条第(二)、(三)、(四)款所述出口许可证的有效期，按《加工贸易业务批准证》核定的出口期限核发。《加工贸易业务批准证》核定的出口期限超过次年2月底的，出口许可证有效期核发至次年2月底，企业应于2月底前申请办理延期手续，发证机构按《加工贸易业务批准证》的出口期限核发出口许可证。

八、根据国务院《关于边境贸易有关问题的通知》(国发[1996]第2号)精神，边境小额贸易企业凡出口配额招标的货物、消耗臭氧层物质、监控化学品、易制毒化学品和摩托车(含全地形车)及其发动机、车架，仍按现行有关规定，在商务部授权的发证机构办理出口许可证。边境小额贸易企业出口边境小额贸易出口许可证管理货物(附件2第1—23种)，由商务部授权的边境省、自治区商务主管部门根据商务部下达的边境小额贸易出口配额签发出口许可证。边境小额贸易企业出口除本条所述以外的其余列入《2006年出口许可证管理货物目录》的货物，一律免领出口许可证。

九、为保证进出口许可证联网核销的实施，对不实行“一批一证”管理的货物，发

证机构在签发出口许可证时必须在许可证“备注”栏内填注“非一批一证”。实行“非一批一证”管理的货物为：（一）外商投资企业出口货物；

（二）加工贸易方式出口货物；

（三）补偿贸易项下出口货物；

（四）大米、玉米、小麦、活牛、活猪、活鸡、牛肉、猪肉、鸡肉、原油、成品油、煤炭。“非一批一证”的出口许可证，可在同一口岸多次报关，但不得超过十二次。当十二次报关后，出口许可证虽有余额，海关停止接受报关。

■ 监控化学品、易制毒化学品和消耗臭氧层物质的货样广告品须凭出口许可证出口。

■ 对涉及出口许可证管理的纺织品目录另行公告。

■ 我国政府在对外援助项下提供的本目录产品（监控化学品和易制毒化学品除外）不纳入配额和许可证管理。本目录自 2006 年 1 月 1 日起执行。《2005 年出口许可证管理商品目录》同时废止。
