MEETING WITH PT CG POWER SYSTEMS INDONESIA, 30 SEPTEMBER 2014

CG Power sought a meeting with the Commission to discuss the dumping margin for PT CG Power System Indonesia (CG Power) published in Statement of Essential Facts no. 219 in relation to exports of power transformers from a number of countries, including the Republic of Indonesia (Indonesia).

CG Power noted the finding of the Commission that it was not a co-operative exporter, and advised that it disagreed with that finding – but that it wished to discuss the information that the Commission had and could use to calculate a dumping margin for CG Power, even if such a finding were made.

CG Power requested that:

- the Commission explain the nature of the information provided by the applicant on which the Commission relied to calculate a dumping margin for CG Power; and
- the Commission consider relying upon information provided by CG Power to calculate the dumping margin, as it maintains such information is relevant and reliable.

The Commission explained the nature of the data relied on to calculate the dumping margin for CG Power, but advised that some of this information was confidential to the applicant and could not be provided to other interested parties.

CG Power considered that the Commission's reservations about the reliability of the data appeared to be the presentation of the data and the ability to cross reference data provided from various sources. The company suggested that the Commission meet with representatives of the CG Power's finance

department to walk through the data provided. CG Power also offered to have an external auditor review the data.

The Commission explained that it had provided CG Power a number of opportunities to rectify deficiencies identified in the data provided and that it was not sufficient to warrant on site verification. It explained that at this stage of the investigation it was not appropriate to commence a verification process, The Commission explained that other exporters had satisfied the Commission that information provided in their exporter questionnaire responses was adequate, including exporters that were not visited by the Commission. The Commission advised that the same standards were applied to assessing the various exporters' responses to exporter questionnaires.

The Commission indicated that it may consider relying on certain data provided by CG Power where such data could be corroborated with information provided by other parties and it was verified by the Commission in the course of the investigation. For example, the Commission indicated it might be possible to find corroborating information in relation to export prices. However, the Commission expected that it would be difficult to identify corroborating information in respect of the normal value information that was submitted by CG Power.

The Commission advised it would consider CG Power's request to meet with company representatives and would advise its decision before the final report was submitted to the Parliamentary Secretary.

CG Power discussed the material injury analysis presented in the SEF and advised that it had concerns about the Commission's analysis, particularly in so far as that analysis related to causation in circumstances where, it appeared to CG Power from the SEF that only a small proportion of sales in the market were at dumped prices.

At the conclusion of the meeting, CG Power advised it will be providing a submission regarding the matters discussed.
