## Alleged dumping of power transformers - "potential for use of alternative approach to dumping margin assessments"

We refer to our previous letters on behalf of ABB Limited of Thailand ("ABB Thailand"), in particular our most recent letter on this topic dated 9 October 2014.

At D2 and D3 of that letter, we advised that **[CONFIDENTIAL TEXT DELETED – serial numbers]** were transformers that were sold under contracts **[CONFIDENTIAL TEXT DELETED – commercial details relating to profitability]**, according to the Anti-Dumping Commission's verified information. However, we also made the point that the full cost model ("FCM") at quotation must be the relevant point at which to consider *"the estimated cost to make and sell the goods.... when pricing the goods"*.

Our client has extracted the FCMs at quotation and we now provide them to you with this letter. [CONFIDENTIAL ATTACHMENTS – details of ABB's costs and prices]

We wish to explain various matters as follows:

- 1 ABB Australia requested a quotation from ABB Thailand [CONFIDENTIAL TEXT DELETED tender and end user information]
- 2 The scope of the request for quotation was:
