Notice of Issuing "Method for Determination of Key Enterprises in Equipment Manufacturing Industry of Zhongshan"

Zhong Fu [2005] No. 127

Administration Committee of Huoju District, town governments, district offices, and units under administration of city:

The "Method for Determination of Key Enterprises in Equipment Manufacturing Industry of Zhongshan" is now issued to you for your implementation.

Zhongshan People's Government July 25, 2005

Method for Determination of Key Enterprises in Equipment Manufacturing Industry of Zhongshan

Clause 1 This method is stipulated for promoting the strategy of industrial strong city and enterprise string city, promoting the transition of the structure of industrial enterprises towards higher level and moderate orientation to heavy industry, and elevating the industrial competitiveness and development level.

Clause 2 The Municipal Leading Group of Accelerating Development of Equipment Manufacturing Industry is responsible for the determination of key enterprises of equipment manufacturing industry, and the Municipal Economic and Trade Bureau is responsible for organizing the implementation of concrete work.

Clause 3 The main scope of the equipment manufacturing industry referred to in this method includes:

- 1. Metal production industry
- 2. General equipment manufacturing industry;
- 3. Special equipment (including medical equipment) manufacturing industry:
- 4. Manufacturing industry of traffic and transportation equipment;
- 5. Manufacturing industry of electric apparatus and appliances;

- Manufacturing industry of telecommunication equipment, computers and other electronic equipment;
- Manufacturing industry of instruments & meters and apparatus for cultural and office purpose.

Clause 4 The application for the municipal key enterprises of equipment manufacturing industry should comply with the following conditions:

- The corporate entity legally established and registered, and the location of industrial and commercial registration is at Zhongshan City;
- The full products or products of main line of enterprise belong to the products of equipment manufacturing industry, and comply with the relative industrial policies of the state, province and city;
- 3. The total assets scale of enterprise is over RMB 30 million Yuan, the yearly sales income is over RMB 50 million Yuan, the yearly paid-in tax is over RMB 3 million Yuan, or the main economic and technical indexes of enterprise are at the forefront or belong to the leading level in the same industry of the country or province, and have the larger potential for development;
- 4. Implementing the brand strategy, having the comparatively strong ability of independent development and technical innovation, and having established the enterprise technical center or the engineering technical research and development center above the city level (including the city level);
- 5. The enterprise has the good credit standing;

Clause 5 The enterprise complying with the regulation in Clause 4 of this method can make application to the economic and trade office of the relevant town or district. After making primary review and comments, the economic and trade office of town will submit it to the Municipal Economic and Trade Bureau, and after organizing the expert group to make review, the Municipal Economic and Trade Bureau will reported to the Municipal Leading Group of Accelerating Development of Equipment Manufacturing Industry of Zhongshan City for determination.

Clause 6 The enterprise applying for the municipal key enterprise of equipment manufacturing industry should submit the following materials:

- Application Form of Zhongshan Key Enterprise of Equipment Manufacturing Industry;
- The financial statements of previous year, tax payment return and the enterprise development plan for future three years;
- Certification of having established the enterprise technical center or the engineering technical research and development center above the city level (including the city level);
- 4. In case of belonging to the leading level of the same industry of the country or

province, the enterprise should submit the certificate produced by the relative industrial association of the country or province.

Clause 7 The key enterprises of equipment manufacturing industry as determined will be issued the plaque and certificate by the municipal government, and be published on the main news media of Zhongshan City.

Clause 8 The relative departments of Municipal Development Planning Commission, Economic and Trade Bureau, Bureau of State Land resources, Bureau of Science and Technology, Environmental Protection Bureau, Foreign Economic and Trade Bureau, and Bureau of Information Industry, etc. should provide prior support to the projects of technical renovation, technical innovation and key technical research and development of the municipal key enterprises of equipment manufacturing industry.

Clause 9 The validity period of the determined municipal key enterprises of equipment manufacturing industry is three years. After expiration, the Municipal Economic and Trade Bureau perform the re-evaluation together with the relative departments.

The Municipal Economic and Trade Bureau will perform the dynamic administration on the municipal key enterprises of equipment manufacturing industry as determined, and the enterprise should report the development of enterprise to the Municipal Economic and Trade Durcau each year.

Clause 10 The Municipal Economic and Trade Bureau should publish the information of application conditions, determination procedure, determination result and supporting policy, etc. for the municipal key enterprise of equipment manufacturing industry so as to guarantee the fairness, openness and justness of the determination work.

Clause 11 The interpretation of this method is the responsibility of the Municipal Economic and Trade Bureau.

Clause 12 This method shall be implemented on the day of promulgation.

6. Specifications for Filling in

- (1) "Research and Development Expenditure" refers to all funds invested by enterprise for the research and development of new products. It includes: expenditure of trial manufacturing of new products, purchase expenditure of testing equipment, expenditure of energy materials, inspection and identification expenditure, salary of development staff, traveling expenses, administration expenses, etc., all of which spent in the whole process of development of new products. It does not include the expenses of new equipments added because of mass production of new products.
- (2) "Unit for Production, Education and Research Cooperation" refers to unit name of college or/and institute with which the enterprise cooperates.
- (3) "Name of Cooperation Institution" refers to name of institution which is established due to the enterprise's cooperation with college or/and institute.
- (4) "Technology level" means whether the technology used in new products reaches international advanced level, or national advanced level, or national advanced level, or fills in domestic blank.

中山市藝备創造业重点企业认定办法

第一条 为推进工业强市和产业强市战略,促进工业产业结构向高级化、适度重型化转变,提升产业竞争力和发展水平,制定本办法。

第三条 本办法所称的坡各制造业的主要范围包括:

- (一) 金属制品业;
- (二)通用设备制造业:
- (三)专用设备(含医疗设备)制造业;
- (四)交通运输设备制造业:
- (五) 电气机械及器材制造业:
- (六) 通信设备、计算机及其他电子设备制造业;
- (七) 仪器仪表及文化办公用机械制造业。

第四条 申请认定市装备制造业重点企业必须符合如下条件;

- (一) 依法登记设立的企业法人,且工商登记注册地为中山市:
- (二)企业全部产品或主业产品周装备制造业产品,且符合国家和省、市有关产业政策:

- (三)企业总资产规模在 3000 万元人民币以上,年销售收入在 5000 万元人民币以上, 年入库税金在 300 万元人民币以上,或企业主要经济技术指标在国内或省内同行业中处于前 列或属于领先水平的,具有较大发展潜力;
- (四)实施名牌战略,拥有较强的自主开发与技术创新能力,已建立市级以上(含市级)企业技术中心或工程技术研究开发中心;
 - (五)企业信誉良好。

第五条 符合本办法第四条规定的企业,可向所属镇区经贸办提出申请。镇区经贸办进行初审并加具意见后,送市经贸局,由市经贸局组织专家组进行评审后,报中山市加快装备制造业发展工作领导小组认定。

第六条 申报市装备制造业重点企业需提交以下资料:

- (一) 中山市装备制造业重点企业申报表。
- (二) 上年度财务报农、纳税证明及今后3年企业发展规划:
- (三)已建立市级以上(含市级)企业技术中心或工程技术研究开发中心证明:
- (四)企业周围内或省内同行业领先水平的,须提交由国家或省相关行业协会出具的证 例。

第七条 经认定的装备制造业重点企业,由市政府颁发牌厦和证书,并在中山市主要新 网媒体公布。

经认定的较备制造业重点企业可以优先享受市技改贷款贴息、科技"三项资金"以及 《关于加快载备制造业发展的意见》规定的各项扶持政策。

第八条 市发展和改革、经贸、国土、科技、环保、外经贸、信息产业等有关部门对市 装备制造业焦点企业的技术改造、技术创新和关键技术研发项目应重点予以支持。

第九条 经认定的市装备制造业型点企业,有效期 3 年。期满后由市经贸局会同有关部门于以重新评中。

市经贸局对经认定的市装备制造业重点企业实行动态管理。企业须每年向市经贸局报告企业发展情况。

第十条 市经贸局应公布市转备制造业重点企业的申请条件、认定程序、认定结果以及 扶持政策等信息,以确保认定工作公平、公开、公正。

第十一条 本办法由市经贸局负责解释。

第十二条 本办法自颁布之日起实施。
