



ANTI-DUMPING NOTICE NO. 2014/69

A3 and A4 copy paper

Exported from the People's Republic of China

Termination of Investigation

Customs Act 1901 – Part XVB

On 10 October 2013 the Anti-Dumping Commission (the Commission) initiated an investigation into the alleged dumping of A3 and A4 copy paper exported to Australia from the People's Republic of China (China), following an application lodged by Paper Australia Pty Ltd (Australian Paper).

The Commission published a notice in *The Australian* on 10 October 2013 notifying of the initiation of the investigation, and issued Anti-Dumping Notice (ADN) 2013/79, which contains further details on the investigation, available at www.adcommission.gov.au.

As a result of the investigation, I, Dale Seymour, the Commissioner of the Anti-Dumping Commission, am satisfied that:

- in relation to UPM (China) Co., Ltd, April Fine Paper Pte Ltd, Zhanjiang Chenming Pulp and Paper Co., Ltd and Sun Paper Industry Joint Stock Co., Ltd, there has been no dumping by those exporters of any of those goods the subject of the application and, therefore, I have decided to terminate the investigation in accordance with subsection 269TDA(1) of the *Customs Act 1901* (the Act) so far as it relates to those exporters;
- in relation to Gold Huasheng Paper (Suzhou Industrial Park) Co Ltd, Gold East Trading (HK) Co., Ltd, the goods exported by that exporter have been dumped, but the dumping margin is negligible (less than two per cent) and, therefore, I have decided to terminate the investigation in accordance with subsection 269TDA(1) of the Act so far as it relates to that exporter; and
- the total volume of goods that have been, or may be, exported to Australia over a reasonable examination period from China that have been, or may be, dumped from all Chinese exporters is negligible and, therefore, I have decided to terminate the investigation so far as it relates to China in accordance with subsection 269TDA(3) of the Act.

In making the decision to terminate, I had regard to the application, submissions from interested parties, *Statement of Essential Facts No. 225*, submissions in response to that statement, and other relevant information.

Termination Report No. 225, which sets out reasons for the termination decision, including the material findings of fact or law upon which the decision is based, has been placed on the Commission's public record, which may be examined at the Commission office by contacting the case manager on the details provided below. Alternatively, the public record is available at www.adcommission.gov.au.

A notice of the decision to terminate was published in *The Australian* newspaper on 7 August 2014.

The applicants may request a review of this decision to terminate the investigation by lodging an application with the Anti-Dumping Review Panel in the approved form and manner within 30 days of the publication of the public notice.
