



ANTI-DUMPING NOTICE NO. 2026/025

Customs Act 1901 – Part XVB

Steel Reinforcing Bar

Exported to Australia from the People's Republic of China

Findings of the Continuation Inquiry No 669 into Anti-Dumping Measures

Public Notice under section 269ZHG(1) of the Customs Act 1901

The Commissioner of the Anti-Dumping Commission (the Commissioner) has completed an inquiry, which commenced on 5 May 2025, into whether the continuation of the anti-dumping measures in the form of a dumping duty notice applying to steel reinforcing bar (the goods) exported to Australia from the People's Republic of China (China) is justified.

Recommendations resulting from that inquiry, reasons for the recommendations, and material findings of fact and law in relation to the inquiry are contained in *Anti-Dumping Commission Report No. 669* (REP 669).

I, TIM AYRES, the Minister for Industry and Innovation and Minister for Science, have considered Report 669 and have decided to accept the recommendation and reasons for the recommendation, including all the material findings of facts and law therein and have decided that the anti-dumping measures applying to steel reinforcing bar exported to Australia from China should continue from 14 April 2026.

Under subsection 269ZHG(1)(b) of the *Customs Act 1901* (the Act), I declare that I have decided to secure the continuation of the anti-dumping measures currently applying to steel reinforcing bar exported to Australia from China.

I determine that pursuant to subsection 269ZHG(4)(a)(iii) of the Act, the notice continues in force after 13 April 2026, but after this day has effect as if different specified variable factors had been fixed in relation to uncooperative and all other exporters, relevant to the determination of duty.

By Anti-Dumping Notice (ADN) No. 2026/026 published on the Anti-Dumping Commission's (commission) website on 25 February 2026, I declared that new variable factors are taken to have been fixed in relation to goods exported to Australia by Baowu

Group Echeng Iron and Steel Co., Ltd (Echeng). I determine that the notice continues after 13 April 2026 in relation to Echeng with the variable factors I declared in ADN No. 2026/026.

Particulars of the dumping margin established for exporters and the effective rate of duty is also set out in the following table.

Uncooperative and all other exporters	19.0%	23.7%	Combination
