**Exported to Australia from the People's Republic of China by
Baowu Group Echeng Iron and Steel Co., Ltd**

Findings in Relation to Review of Anti-Dumping Measures No 676

***Notice under section 269ZDB(1) of the Customs Act 1901 and
section 8(5) of the Customs Tariff (Anti-Dumping) Act 1975***

The Commissioner of the Anti-Dumping Commission has completed a review, which commenced on 26 May 2025, of the anti-dumping measures applying to steel reinforcing bar (the goods) exported to Australia from the People's Republic of China (China) by Baowu Group Echeng Iron and Steel Co., Ltd (Echeng).

Recommendations resulting from that review, reasons for the recommendations and material findings of fact and law in relation to the review are contained in *Anti-Dumping Commission Report No. 676* (REP 676).

I, TIM AYRES, Minister for Industry and Innovation and Minister for Science, have considered REP 676 and have decided to accept the recommendations and reasons for the recommendations, including all the material findings of facts or law set out in REP 676.

Under section 269ZDB(1)(a)(iii) of the *Customs Act 1901* (the Act), I declare, for the purposes of the Act and the *Customs Tariff (Anti-Dumping) Act 1975* (Dumping Duty Act), that, with effect from the date of publication of this notice the dumping duty notice currently applying to the goods exported to Australia from China by Echeng is to be taken to have effect as if different variable factors had been fixed in respect of Echeng relevant to the determination of duty.

In accordance with section 8(5BB) of the Dumping Duty Act, and the *Customs Tariff (Anti-Dumping) Regulation 2013* (the Regulation), the duty that has been determined is an amount worked out in accordance with the floor price duty method pursuant to sections 5(4) and (5) of the Regulation as detailed in the table below.

Particulars of the dumping margin established, the fixed interim dumping duty (IDD), and duty method is set out in the following table.
