



ANTI-DUMPING NOTICE NO. 2018/160

Investigation into alleged dumping of ammonium nitrate

Exported from the People's Republic of China, Sweden and the Kingdom of Thailand

Extensions of time granted to issue the Statement of Essential Facts and the Final Report

Customs Act 1901 – Part XVB

On 25 June 2018, the Commissioner of the Anti-Dumping Commission (Commissioner) published a notice announcing the initiation of an investigation into the alleged dumping of ammonium nitrate (the goods) exported to Australia from the People's Republic of China (China), Sweden and the Kingdom of Thailand (Thailand).

The background to the initiation of this investigation and a full description of the goods is available in Anti-Dumping Notice (ADN) No. 2018/103 (initiation notice). The initiation notice is available on the Anti-Dumping Commission's (Commission) website at www.adcommission.gov.au.

The initiation notice advised that a statement of essential facts (SEF) would be placed on the public record by 13 October 2018.¹ It also advised that a recommendation to the Minister for Industry, Science and Technology (the Minister) would be made in a final report on or before 27 November 2018.

To complete all verification activities and publish relevant reports on the Commission's website, and to properly consider additional information provided by CSBP Limited, Orica Australia Pty Ltd and Queensland Nitrates Pty Ltd in separate submissions concerning injury and causation, I, Paul Sexton, General Manager, Investigations, requested an extension of time, under subsections 269ZHI(1)(a) and 269ZHI(1)(b) of the *Customs Act 1901* (the Act), to the deadline for the Commissioner to publish the SEF and provide his final report and recommendation to the Minister.²

¹ Day 110 of the investigation is 13 October 2018 which is a Saturday. Therefore, the next business day becomes the due date for publication of the SEF.

² On 15 December 2016, the Commissioner delegated his powers and functions under section 269ZHI of the *Customs Act 1901* to the General Managers of the Anti-Dumping Commission.

The Commissioner has, under subsection 269ZHI(3) of the Act, extended the deadline to publish the SEF, and provide his report and recommendations to the Minister.³

The SEF will now be placed on the public record no later than **17 December 2018**. Interested parties are invited to make submissions to the Commissioner in response to the SEF within 20 days of the SEF being placed on the public record. If the investigation is not terminated earlier, a recommendation to the Minister will now be made in a report due on or before **31 January 2019**.
