ANTI-DUMPING NOTICE NO. 2019/08

Food Service and Industrial Pineapple

Exported to Australia from the Kingdom of Thailand

Findings in Relation to Review of Anti-Dumping Measures No. 477

Notice under subsection 269ZDB(1) of the Customs Act 1901

The Commissioner of the Anti-Dumping Commission has completed a review, which commenced on 10 May 2018, of the anti-dumping measures applying to food service and industrial pineapple (FSI pineapple or the goods) exported to Australia from the Kingdom of Thailand (Thailand) by Prime Products Industry Co., Ltd. (PPI). The review examined whether the anti-dumping measures should be revoked or varied.

Recommendations resulting from that review, reasons for the recommendations and material findings of fact and law in relation to the review are contained in *Anti-Dumping Commission Report No. 477* (REP 477).

I, KAREN ANDREWS, the Minister for Industry, Science and Technology¹ have considered REP 477 and have decided to accept the recommendations and reasons for the recommendations, including all the material findings of facts or law set out in REP 477.

Under subsection 269ZDB(1)(a)(ii) of the *Customs Act 1901* (the Act), I declare, for the purposes of the Act and the *Customs Tariff (Anti-Dumping) Act 1975* (Dumping Duty Act), that, with effect from 10 May 2018², the dumping duty notice currently applying to the goods exported to Australia from Thailand be revoked in relation to PPI.

Interested parties may seek a review of this decision by lodging an application with the Anti-Dumping Review Panel (www.adreviewpanel.gov.au) in accordance with the requirements in Division 9 of Part XVB of the Act, within 30 days of the publication of this notice.

¹ For the purpose of this decision the Minister is the Minister for Industry, Science and Technology.

² A retrospective date allowed under subsection 269ZDB(6)(a) of the Act, being the date of the publication of the initiation notice under section 269ZC of the Act indicating the Commissioner's proposal to undertake a revocation review.
