



CONTINUATION INQUIRY

Prepared or preserved tomatoes

Exported from Italy¹

File Note - Extension of time for Questionnaire responses and Preliminary Information Requests received

On 16 July 2018, the Anti-Dumping Commission (the Commission) notified exporters of prepared or preserved tomatoes exported to Australia from Italy (subject to the relevant anti-dumping notice) that questionnaire responses in relation to this continuation inquiry were due by no later than 22 August 2018.

The Commission has received requests for extensions of time to the due date from certain exporters within the legislated period, who have communicated their intent to cooperate with the inquiry. Due consideration has been given to the extension requests by a General Manager of the Commission, having regard to the exporters' individual circumstances and the *Customs (Extensions of Time and Non-cooperation) Direction 2015*.²

The following table summarises the extensions of time given in relation to individual exporters and provides a summary of the revised due dates:

The Commission also received requests for extensions of time to the due date for the preliminary information request (PIR) from some exporters. Due consideration has been given to the extension requests however no extension of time was given to any exporter for the submission of the PIR.

The Commission will consider all PIR responses received within the submission timeframe and determine whether they are eligible to be considered to be a residual exporter for the purposes of this inquiry. The following entities have submitted a PIR:
