## **Further extension of time granted to issue the Statement of Essential Facts and the Final Report**

### **in relation to Review of Anti-Dumping Measures No 509**

*Customs Act 1901 – Part XVB<sup>1</sup>*

On 26 April 2019, the Commissioner of the Anti-Dumping Commission (Commissioner) published a notice announcing the initiation of a review of anti-dumping measures, in the form of a dumping duty notice and a countervailing duty notice, in respect of aluminium extrusions (the goods) exported to Australia from Malaysia by EverPress Aluminium Industries (EverPress).

A full description of the goods is available in that notice, Anti-Dumping Notice (ADN) No. 2019/59 (initiation notice). The initiation notice is available on the Anti-Dumping Commission's (the Commission's) website at [www.adcommission.gov.au](http://www.adcommission.gov.au)

The initiation notice advised that the statement of essential facts (SEF) would be placed on the public record on or before 14 August 2019. The initiation notice also advised that a recommendation to the Minister for Industry, Innovation and Technology (the Minister) would be made in a final report on or before 28 September 2019.

On 1 August 2019, the Commissioner extended the time period for publishing the SEF to 28 September 2019; and extended the time period for providing the final report to the Minister to 12 November 2019.<sup>2</sup>

I, Paul Sexton, General Manager, Anti-Dumping Commission, requested a further extension to these time periods to fully examine issues surrounding the request for revocation of the countervailing duty notice.

Specifically, I made a written request to the Commissioner for:

- an extension under subsection 269ZHI(1)(d), of the time period referred to in subsection 269ZD(1) of the Act; and
- an extension under subsection 269ZHI(1)(e), of the time period referred to in subsection 269ZDA(1) of the Act.<sup>3</sup>

The Commissioner has, under subsection 269ZHI(3) of the Act<sup>4</sup>, extended the time period for publishing the SEF, and extended the time period for providing his final report and recommendation to the Minister.<sup>5</sup>

The SEF will now be placed on the public record no later than **21 October 2019**. Interested parties are invited to make submissions in response to the SEF within 20 days of the SEF being placed on the public record.

A recommendation to the Minister will now be made in a report due on or before **3 December 2019**.
