**Extensions of time granted to issue the
Statement of Essential Facts and the Final Report
in relation to Reviews of Anti-Dumping Measures No. 521 & 522**

Customs Act 1901 – Part XVB

On 23 August 2019, the Commissioner of the Anti-Dumping Commission (Commissioner) published a notice announcing the initiation of reviews of anti-dumping measures, in the form of dumping duty notices and countervailing duty notices, in respect of certain zinc coated (galvanised) steel exported to Australia from the People's Republic of China (China),¹ the Republic of India,² the Republic of Korea,³ Malaysia,⁴ Taiwan,⁵ and the Socialist Republic of Vietnam,⁶ and certain aluminium zinc coated steel exported to Australia from China, as they affect exporters of those goods generally.

A full description of the goods is available in that notice, Anti-Dumping Notice (ADN) No. 2019/100 (initiation notice). The initiation notice is available on the Anti-Dumping Commission (Commission) website at www.adcommission.gov.au.

The initiation notice advised that the statement of essential facts (SEF) would be placed on the public record on or before 11 December 2019. The initiation notice also advised that a recommendation to the Minister for Industry, Science and Technology (the Minister) would be made in a final report on or before 25 January 2020.

As advised in ADN No. 2019/147, the Commissioner has previously extended these deadlines. The SEF is currently due to be placed on the public record on or before 9 April 2020, and a recommendation provided to the Minister in a report on or before 24 May 2020. Due to the scale of the reviews, the number of countries involved and additional delays in undertaking the Commission's verification activities, I, Paul Sexton, General Manager, Anti-Dumping Commission requested a further extension of the deadline for the Commissioner to publish the SEF and provide his final report and recommendation to the Minister.⁷

The Commissioner has, under subsection 269ZHI(3) of the *Customs Act 1901*,⁸ extended the deadline to publish the SEF, and provide his final report and recommendation.

The SEF will now be placed on the public record on or before **8 July 2020**. Interested parties are invited to make submissions to the Commissioner in response to the SEF within 20 days of the SEF being placed on the public record. A recommendation to the Minister will now be made in a report due on or before **22 August 2020**.⁹
