



ANTI-DUMPING NOTICE NO. 2020/053

Resealable can end closures Exported from Malaysia by Federal Metal Printing Factory Sdn Bhd

Extension of time granted to issue the Statement of Essential Facts and the Final Report in relation to Review of Anti-Dumping Measures No 527

Customs Act 1901 – Part XVB

On 1 October 2019, the Commissioner of the Anti-Dumping Commission (Commissioner) published a notice announcing the initiation of a review of anti-dumping measures, in the form of a dumping duty notice, in respect of resealable can end closures (the goods) exported to Australia from Malaysia by Federal Metal Printing Factory Sdn Bhd (Federal Metal), an exporter of the goods.

A full description of the goods is available in that notice, Anti-Dumping Notice (ADN) No. 2019/122 (initiation notice). The initiation notice is available on the Anti-Dumping Commission's (Commission) website at www.adcommission.gov.au.

The initiation notice advised that the statement of essential facts (SEF) would be placed on the public record on or before 19 January 2020. The initiation notice also advised that a recommendation to Minister for Industry, Science and Technology (the Minister) would be made in a final report on or before 4 March 2020.

As advised in ADN No. 2020/031, the Commissioner has previously extended these deadlines. The SEF is currently due to be placed on the public record on or before 18 May 2020, and a recommendation provided to the Minister in a report on or before 2 July 2020.

Due to additional delays in the timing of the Commission's verification activities as a result of COVID-19 related measures in Malaysia, I, Paul Sexton, General Manager, Anti-Dumping Commission, requested a further extension of the deadline for the Commissioner to publish the SEF and provide his final report and recommendation to the Minister.¹

The Commissioner has, under subsection 269ZHI(3) of the *Customs Act 1901*,² extended the deadline to publish the SEF, and provide his final report and recommendation to the Minister.

The SEF will now be placed on the public record on or before **15 September 2020**. Interested parties are invited to make submissions to the Commissioner in response to the SEF within 20 days of the SEF being placed on the public record.

A recommendation to the Minister will now be made in a report due on or before **30 October 2020**.
