ANTI-DUMPING NOTICE NO. 2020/098

Aluminium extrusions exported to Australia from Malaysia and the Socialist Republic of Vietnam

Extension of time granted to issue the Statement of Essential Facts and the Final Report in relation to Review of Anti-Dumping Measures No. 544

On 24 February 2020, the Commissioner of the Anti-Dumping Commission (the Commissioner) published a notice announcing the initiation of a review of the anti-dumping measures applying to certain aluminium extrusions (the goods) exported to Australia from Malaysia and the Socialist Republic of Vietnam (Vietnam). The anti-dumping measures are in the form of a dumping duty notice (Malaysia and Vietnam) and a countervailing duty notice (Malaysia only).¹

A full description of the goods is available in Anti-Dumping Notice (ADN) No. 2020/014 (initiation notice). The initiation notice is available on the Anti-Dumping Commission (Commission) website at: www.adcommission.gov.au

The initiation notice advised that the statement of essential facts (SEF) would be placed on the public record on, or before, 15 June 2020.² The initiation notice also advised that a recommendation to the Minister for Industry, Science and Technology (the Minister) would be made in a final report on, or before, 28 July 2020.

As advised in ADN No. 2020/063, the Commissioner has previously extended this deadline. The SEF is currently due to be placed on the public record on, or before, 1 September 2020, and a recommendation provided to the Minister in a report on, or before, 28 October 2020.

To provide further time to complete the verification phase of the review and have full consideration of the available information in preparing the SEF, I, Paul Sexton, General Manager, Investigations of the Anti-Dumping Commission, requested an extension of the deadline for the Commissioner to publish the SEF and provide his final report and recommendation to the Minister.³

The Commissioner has, under section 269ZHI(3) of the *Customs Act 1901*, extended the deadline to publish the SEF, and provide the final report and recommendation.⁴ The SEF will now be placed on the public record on, or before, **13 October 2020**.

Interested parties are invited to make submissions to the Commissioner in response to the SEF within 20 days of the SEF being placed on the public record. A recommendation to the Minister will now be made in a report due on, or before, **9 December 2020**.
