Findings in Relation to Review of Anti-Dumping Measures No. 547

Notice under subsection 269ZDB(1) of the Customs Act 1901 (Cth)

The Commissioner of the Anti-Dumping Commission has completed a review, which commenced on 12 March 2020, of the anti-dumping measures applying to A4 copy paper (the goods) exported to Australia from Republic of Indonesia by Pt Indah Kiat Pulp & Paper Tbk (Indah Kiat) and Pt Pindo Deli Pulp and Paper Mills (Pindo Deli).

Recommendations resulting from that review, reasons for the recommendations and material findings of fact and law in relation to the review are contained in *Anti-Dumping Commission Report No. 547* (REP 547).

I, KAREN ANDREWS, the Minister for Industry, Science, and Technology have considered REP 547 and have decided to accept the recommendations and reasons for the recommendations, including all the material findings of facts or law set out in REP 547.

Under subsection 269ZDB(1)(a)(ii) of the *Customs Act 1901* (Cth) (the Act), I declare, for the purposes of the Act and the *Customs Tariff (Anti-Dumping) Act 1975* (Cth) (Dumping Duty Act), that, with effect from 12 March 2020 the dumping duty notice applying to the goods exported to Australia from Indonesia is taken to have been revoked in relation to Indah Kiat and Pindo Deli.

Interested parties may seek a review of this decision by lodging an application with the Anti-Dumping Review Panel (<u>www.adreviewpanel.gov.au</u>) in accordance with the requirements in Division 9 of Part XVB of the Act, within 30 days of the publication of this notice.
