



# **ANTI-DUMPING NOTICE NO. 2021/090**

## **Copper tube**

### **Exported to Australia from the Socialist Republic of Vietnam**

### **Investigation No. 580 into Alleged Dumping**

### **Extension of time granted to issue the Statement of Essential Facts and the Final Report**

*Customs Act 1901 (Cth) – Part XVB*

On 22 March 2021, the Commissioner of the Anti-Dumping Commission (Commissioner) published a notice announcing the initiation of an investigation into the alleged dumping of copper tube (the goods) exported to Australia from the Socialist Republic of Vietnam (Vietnam).

A full description of the goods is available in Anti-Dumping Notice (ADN) No. 2021/41 available on the Anti-Dumping Commission's (Commission) website at [www.adcommission.gov.au](http://www.adcommission.gov.au) (initiation notice).

The initiation notice advised that the statement of essential facts (SEF) would be placed on the public record by 12 July 2021.<sup>1</sup> The initiation notice also advised that a recommendation to the Minister would be made in a final report on, or before, 24 August 2021.

As the exporter verification is in progress, and in order to fully consider issues raised in the application and responses to the importer and exporter questionnaires, I, Paul Sexton, General Manager, Investigations of the Anti-Dumping Commission, requested an extension of the deadline for the Commissioner to publish the SEF and provide his final report and recommendation to the Minister.<sup>2</sup>

The Commissioner has, under section 269ZHI(3) of the Act, extended the deadline to publish the SEF, and provide the final report and recommendation.<sup>3</sup>

The SEF will now be placed on the public record no later than **8 October 2021**.

Interested parties are invited to make submissions to the Commissioner in response to the SEF within 20 days of the SEF being placed on the public record.

A recommendation to the Minister will now be made in a report due on, or before, **22 November 2021**.
