## ANTI-DUMPING NOTICE NO. 2022/041

## Wire rope exported from the Republic of South Africa

## Extension of time granted to issue the Statement of Essential Facts and Report to the Minister in relation to Continuation No 595

Customs Act 1901 - Part XVB

On 17 January 2022, the Commissioner of the Anti-Dumping Commission (Commissioner) published a notice announcing the initiation of an inquiry. The inquiry relates to whether the anti-dumping measures in respect of wire rope (the goods) exported to Australia from the Republic of South Africa (South Africa), should continue.

The notice advised that the statement of essential facts (SEF) would be placed on the public record by 7 May 2022.<sup>1</sup> The SEF will set out the facts on which the Commissioner proposes to base his recommendations to the Minister for Industry, Energy and Emissions Reduction (the Minister) in relation to this inquiry. The notice also advised that a recommendation to the Minister would be made in a final report on, or before, 21 June 2022.

An extension of time has been requested to publish the SEF and provide a report to the Minister. Specifically, the extension of time will permit completion of the commission's verification activities and particular market situation inquiries.

For this reason, I, Isolde Lueckenhausen, General Manager, Investigations of the Anti-Dumping Commission, requested an extension of the deadline for the Commissioner to publish the SEF and provide a report to the Minister.<sup>2</sup>

The Commissioner has, under section 269ZHI(3) of the *Customs Act 1901*, extended the deadline to publish the SEF and provide the report to the Minister.<sup>3</sup>

The SEF will now be placed on the public record no later than **31 August 2022** and a report will be provided to the Minister no later than 1 November 2022. Interested parties are invited to make submissions to the Commissioner in response to the SEF within 20 days of the SEF being placed on the public record.
