## Application for Accelerated Review of Anti-Dumping Measures – HENGYUAN

Dear Commissioner of the Anti-Dumping Commission,

Dashiqiao Hengyuan Aluminum Products Co., Ltd. (the “Applicant”) would like to seek an Accelerated Review of Anti-Dumping Measures that apply to the goods of Aluminium Extrusions covered by GUC 1 ‘Aluminium extrusions’, 2 ‘Aluminium extrusions with minor working’, 3 ‘Aluminium extrusions that are parts intended for use in intermediate or finished products’ and 4 ‘Aluminium extrusions that are themselves finished products’.

Specifically, the Applicant supplies Aluminium extrusions produced via an extrusion process, of alloys having metallic elements falling within the alloy designations published by The Aluminium Association commencing with 1, 2, 3, 5, 6 or 7 (or proprietary or other certifying body equivalents), with the finish being as extruded (mill), mechanical, anodized or painted or otherwise coated, whether or not worked, having a wall thickness greater than 0.5 mm, with a maximum weight per metre of 27 kilograms and a profile or cross-section which fits within a circle having a diameter of 421 mm.
