TERMINATION OF THE INVESTIGATION
PUBLIC NOTICE UNDER SECTION 2691DA
On 9 September 2011, the delegate of the Chief Executive Officer (CEO) of the Australian Customs and Border Protection Service (Customs and Border Protection) initiated an investigation into the alleged dumping of structural timber exported to Australia from the above-named countries.

In relation to the following exporters, there has been no dumping by those exporters of any of those goods the subject of the application and, therefore, I have decided to terminate the investigation in accordance with s 2691DA(1) of the Customs Act 1901 so far as it relates to those exporters.

In making the decisions to terminate, I considered the application, submissions from interested parties, statement of essential facts no 176 (SEF 176), submissions in response to SEF 176 and other relevant information.
