Notice under section 269ZZM(4)

A4 Copy Paper Exported from the Federative Republic of Brazil, the People's Republic of China, the Republic of Indonesia and the Kingdom of Thailand

The Anti-Dumping Review Panel (ADRP) has completed a review of the decisions by the former Parliamentary Secretary to publish notices under subsections 269TG(1) & (2) and subsections 269TJ(1) & (2) of the *Customs Act 1901* in respect of A4 Copy Paper Exported from the Federative Republic of Brazil, the People's Republic of China, the Republic of Indonesia and the Kingdom of Thailand (the Reviewable Decision). The Reviewable Decisions were published on the Anti-Dumping Commission (ADC) website on 19 April 2017 ([ADN 2017/39](#) & [ADN 2017/40](#)).

Applications for review were made by the following:

The ADRP has recommended that the Reviewable Decision be revoked and substituted with a new decision that is in the same terms as the Reviewable Decision except that a different normal value be ascertained for-

- Asia Symbol (Guangdong) Paper Co., Ltd, resulting in a dumping margin of 3 per cent (previously 3.1 per cent); and
- PT Indah Kiat Pulp & Paper Tbk, resulting in a dumping margin of 30 per cent (previously 35.4 per cent); and
- PT Pindo Deli Pulp and Paper Mills, resulting in a dumping margin of 33 percent (previously 38.6 per cent).

I, ZED SESELJA, Assistant Minister for Science, Jobs and Innovation/Parliamentary Secretary to the Minister for Jobs and Innovation have considered and accepted the recommendations, and reasons for the recommendations, made by the ADRP in ADRP Report No 55, including all material findings of fact or law as set out in ADRP Report No 55.

Therefore, in accordance with section 269ZZM(1)(b) of the *Customs Act 1901* I **revoke** the reviewable decision in so far as it relates to Asia Symbol Paper (Guangdong) Co., Ltd, PT Indah Kiat Pulp & Paper Tbk and PT Pindo Deli Pulp and Paper Mills and substitute new decisions as recommended by the ADRP. The substituted decision is to have effect from the date of the reviewable decision.

Interested parties may seek a review of this decision by lodging an application with the Federal Court of Australia, in accordance with the requirements in the *Administrative Decisions (Judicial Review) Act 1977*, within 28 days of the publication of this notice.
