Please be advised that the Anti-Dumping Review Panel (“ADRP”) review of Certain Zinc Coated (Galvanised) Steel and Certain Aluminium Zinc Coated Steel exported from the Republic of Korea by Donbgu Steel Co. Ltd was initiated on 31 August 2017.

For the purpose of obtaining further information in relation to the review, the ADRP Member requests the Anti-Dumping Commission (“ADC”) provide the following documents:

3. Any confidential attachments to the Final Report (assuming the full Final Report will otherwise be on the public record)

4. Any other *relevant information* (as defined in s269ZZK *Customs Act 1901*) pertinent to the grounds of review raised by the Applicant(s), for example:
  - If the grounds relate to normal value and/or export price, please provide any confidential information/spreadsheets from the exporter regarding the calculation of the normal value, export price and dumping margins.
5. Any other records/documents that contain information about the verification report/s.

### **Confidential and Public ADC Documents**

Only confidential versions of documents need to be provided. Public versions of documents that have been published on the ADC website, including on the Electronic Public Record for the relevant case, are not required.
